Detention Center – Online & Batch (Update for SY 2022 and later)

Requirements:

• During a School Year, if a student has been detained and has been receiving services in a county detention center, then either the respective county detention center or the Home school district tied to that county detention center should report it to SIS by sending a detention center record through online or batch. Student may or may not be enrolled at another district.

Validations:

- Only students grades 6 to 12 can be entered into a detention center while the students is in Illinois
 - The Detention Center student should have a valid SIS enrollment.
- Detention Center RCDTS or Home RCDT who are tied to a Detention Center RCDTS can add/update the Detention Center records.
- The current school year starts on 08/01 (After 08/01 detention records can be entered from 07/01 to 07/31 for the current school year).
- Data can be entered until August 31 of the new school year
- Only students grades 6 to 12 can be entered into a detention center while the students is in Illinois.
- Service Start and Service End dates may not overlap other Service Start and End entries
- All dates must be valid and are in mm/dd/yyyy format.
- Dates may not be in the future.
- The Detention Center RCDTS is a valid RCDTS for the student's grade.

Enrollment/Exit Enrollment

Rename "Tuition – In" to "Tuition Received" (Update for SY 2022 and later)

Requirements:

• Under Enrollment, the data element **"Tuition-In"** should be renamed to **"Tuition Received"**

Changes for House Bills 40 and 2748

IDEA Students - Age Validations (Update for only SY 2022)

Requirements:

• IDEA Students who turned 22 Years in School Year 2021 and were not able to receive services are eligible to resume/receive services in School Year 2022

Validations:

- If IDEA Services = 'Yes' and Age is less than 24 years as on enrollment date, then allow student to enroll
- IF IDEA Services = 'Yes' and Age is less than 24 years as on exit date, then allow student to exit

Exit Type Validation (Update only for SY 2022)

Requirements I:

- IDEA student turned 22 during the 2021 school year, are allowed to re-enroll for services in the 2022 school year
- IDEA students who were exited as **Graduated** or **Aged Out** in SY 2021 **should be allowed** to enroll in SY 2022

Validations:

• In SY 2021, IF IDEA Services = 'Yes' and student is exited with Exit Type = (Graduated or Aged Out) allow the student to enroll in SY 2022 (considering the age validations for IDEA students were met)

Requirements II:

 IDEA students who turned 22 years and were exited as Death or Expulsion or Moved Out of the United States in SY 2021 should not be allowed to enroll in SY 2022

Validations:

 IF IDEA Services = 'Yes' AND Date of Birth > 22 years as on enrollment date AND last enrollment in SY 2021 has been exited with Enrollment Exit/Withdrawal Type = 07-Death or 08-Expulsion or 18-Moved out of the United States then block the enrollment

Student Demographics – Gender (Update for SY 2022 and later)

Requirements:

• In Student Demographics, a new option 'Non-Binary' should be added under 'Gender'

Validations:

• Under 'Gender' a new radio button option Non-Binary (03 or N) should be added

English Learners (EL) Status Flag (Update for SY 2022 and later)

Requirements:

- Four EL status flags are being introduced to identify the student's EL Status
 - 1. Never EL (Student who was never identified as an EL)
 - 2. Currently EL (Student who is currently receiving EL services)
 - 3. Former EL (Student who received EL services and attained Proficiency)
 - 4. Former EL [Pre-K Only] (Student who was identified as an EL in Pre-K but identified as proficient when screened with 'MODEL' test in Kindergarten or 1st semester of first grade)
- The EL Status flag will be stamped on EL Indicator which is located in the Program Indicators tab

Requirements:

1. Three new required fields during data collection/updates:

- a. Education Received
- b. Employment Status
- c. Is Homeless

2. Updates:

- a. View Marital Status History
- b. Entity Search for RCDT and RCDTS
- c. Services Section
 - i. Can add/view more than one FY now, no need to end service due to Fiscal Year

Validations:

- Education Received must be selected
 - o If empty, a validation error will occur
- Employment Status must be selected
 - o If empty, a validation error will occur
- Is Homeless must be selected
 - o If empty, a validation error will occur

Validations:

• Indicator Page:

- o Family Structure must be selected
 - If empty, a validation error will occur
- o Child Welfare Involvement Within the Past Year must be selected
 - If empty, a validation error will occur
- Child of Teen Parents must be selected unless the Family Structure is "Youth in Care"
 - If Family Structure is not "Youth in Care" AND the Child of Teen Parents field is empty, a validation error will occur
 - If Family Structure is "Youth in Care" AND the Child of Teen Parents field is empty, no validation error occurs
 - If Family Structure is "Youth in Care" AND the Child of Teen Parents field is filled in, no validation error occurs
- Number of Months Child was Breastfed during Enrollment must be selected
 - If empty, a validation error will occur
- o Infant Born with a Low Birth Weight must be selected
 - If empty, a validation error will occur
- Preterm Birth (before 37 weeks) must be selected unless the Family Structure is "Youth in Care"
 - If Family Structure is not "Youth in Care" AND the Preterm Birth (before 37 weeks) field is empty, a validation error will occur
 - If Family Structure is "Youth in Care" AND the Preterm Birth (before 37 weeks) field is empty, no validation error occurs
 - If Family Structure is "Youth in Care" AND the Preterm Birth (before 37 weeks) field is filled in, no validation error occurs

 - If empty, a validation error will occur

Requirements:

- 1. Programs and providers Page
 - a. New Optional Fields:
 - i. Gateway Registry member ID
 - ii. Provider has a Gateways Credential

Validations:

- Programs and providers Page:
 - Gateways Registry Member ID (optional)
 - Must be 18 characters or less
 - If greater than 18 characters, a validation error will occur
 - Provider has a Gateways Credential (optional)
 - No validation requirements, even if the Gateways Registry Member ID is filled in
