## Illinois State Board of Education Assessment Enrollment Verification Report Guidelines for Assessments

This document outlines the steps and dates for district/school staff to ensure spring 2023 assessment data accuracy for the Illinois Assessment of Readiness (IAR), SAT with Essay, PSAT 10, PSAT 8/9, and Dynamic Learning Maps Alternate Assessment (DLM-AA).

- Score matching issues are largely due to missing or incorrect enrollments in ISBE's Student Information System (SIS).
- The deadline for districts to add and correct school year 2022-23 SIS enrollment data is July 31, 2023.
- Review the Assessment Enrollment Verification Report to ensure accurate SIS enrollments exist before scores are posted.

## Action Needed by District/School Staff

**Review the** *Assessment Enrollment Verification Report*. This report identifies students enrolled in SIS during the testing windows, the assessment type, and home school.

- Verify that report counts match your local assessment roster and the students who tested:
  - Appear on the report (i.e., enrolled in SIS during the test window).
  - Show the correct grade level at the time of testing.
  - o Show the appropriate *Test to Be Taken*. (IDEA Indicator and Alternate Assessment must be "Yes" for DLM-AA.)
  - Show accurate First Year in U.S. School indicator (from the "EL Information" tab in SIS enrollment).

**Review** Assessment Scores and Unassigned Reports. Scores were posted on June 27 for DLM-AA and are anticipated to be posted on July 11 for IAR and on July 12 for SAT/PSAT.

- Ensure scores are matched for all students who tested or partially tested, as applicable.
- Review and account for all unassigned test records.
- Resolve report errors. (For example, student score data is expected but missing. Apply Reason for No Valid Test Attempt (RNVTA) for students without scores.)
  - o If a student transferred out of your school before testing, use RNVTA 07.
  - o If a student transferred into your school after testing, use RNVTA 08.
  - o If no listed RNVTA code applies, use RNVTA 10.
  - o If Private School Student is exempt from testing, use RNVTA 16. (Must meet PSS definition.)

April 11, 2023	Assessment Enrollment Verification Report is available in SIS for IAR, DLM-AA, SAT with Essay, PSAT 10, and PSAT 8/9. District and school staff should compare this report with local records to verify all tested students are reported correctly. The report highlights students with multiple enrollments during the window. If student is not on report, enroll student in SIS during the testing window immediately. To access this report, log in to SIS, choose "Reports" on the left, then "Student," then "Assessment," then "Assessment Enrollment Verification Report," and "Details."
Deadline July 31, 2023	Districts verify that all enrollments in SIS are accurate. Enrollments cannot be adjusted after 4 p.m. Monday, July 31, 2023.
Anticipated: May 17, 2023	Assessment Correction Report is available in SIS for IAR, DLM-AA, SAT with Essay, PSAT 10, and PSAT 8/9.  District/school staff may enter RNVTA codes based on local testing rosters. To access this report, log in to SIS, choose "Reports" on the left, then "Student," then "Assessment," open the desired Assessment, and click the "Correction" report, and choose "Details."
Posted: June 27, 2023 (DLM-AA) Anticipated: July 11, 2023 (IAR) July 12, 2023 (SAT/PSAT)	Assessment Scores Report is available (score data available) in SIS for IAR, DLM-AA, SAT with Essay, PSAT 10, and PSAT 8/9. District/school staff may continue to enter RNVTA codes, review/resolve unassigned test results, and clear reported error codes. To access this report, log in to SIS, choose "Reports" on the left, then "Student," then "Assessment," open the desired Assessment, and click the "Scores" report, and choose "Details."
August 25, 2023	Final day to review assessment data, match unassigned test records, resolve any errors, and enter RNVTA codes for IAR, DLM-AA, SAT with Essay, PSAT 10, and PSAT 8/9.
