

CONTEXTUAL INFORMATION

Mission:

Blackburn College, founded in 1837 and affiliated with the Presbyterian Church (USA), provides a coeducational student body with a rigorous, distinctive, and affordable liberal arts education that prepares graduates to be responsible, productive citizens. The Blackburn community values critical and independent thinking, leadership development, respect for all individuals, and lifelong learning. The college fosters a sense of service, community, and moral responsibility through its unique student-managed work program, its collegial concept of shared governance, and its faculty/staff mentor relationship with students.

Teacher Preparation Programs:

The emphasis of the Department of Education is on providing candidates with the professional education coursework and field experiences needed for Illinois certification in Elementary Education (K-9), Secondary Education (9-12), or Special Certificate (K-12). The Department of Education offers eight different certification designations:

Student Characteristics:

The majority of students at Blackburn College are of traditional college age with gender distribution of 54.4% female, 45.6% male. Of all students, 96.9% attend full-time, and 13% are of ethnically diverse backgrounds. Approximately one-fourth (165) of the 643 students attending Blackburn College are enrolled in the Teacher Education Program.

4. Grade of C or better in all ED courses

7. Submit Dispositions Evaluations

- In their first education course, Education students participate in 35 hours of hands-on tutoring with K-12 students.
