Summer Food Service Programs are eligible to receive \$0.015 per meal claimed in the SFSP in 2010; this is called Planned Assistance Level (PAL). Below is a list of commodities that may be available. Please write in your requested amount; you may go over your PAL dollars by 25 percent. We will try to send all of your requests, but that is not always possible. To calculate your PAL dollars for the SFSP, take the total meals claimed in SFSP for 2010 x \$0.015, then multiply by 1.25 (for the 25% over). The bonus commodities available below may be requested as needed; they do not go against your PAL dollars. Your request will be filled based on availability.
