Professional Organizations

Several professional organizations provide membership benefits to medical assistants. Some provide accreditation. Others provide job placement services. Also, some provide the opportunity for continuing education. Professional organizations may provide educational grants and scholarships to help finance your tuition. Membership can create opportunities for you to advocate for your career interests and share your voice in local, state, and national forums.

Professional Terms

Organizations **accredit**, or recognize, educational institutions that maintain standards to qualify graduates for professional practice. **Certification** is a voluntary process that a medical assistant seeks by pursuing specialized training. To be certified, a medical assistant is evaluated and recognized as having met a certain standard of knowledge and skills.



Continuing education (**CE**) is typically required on an annual basis by the state to maintain licensure. **CEUs** are continuing education units, similar to credit hours. A **CMA** is a certified

medical assistant. The designation CMA is awarded to a medical assistant who has graduated from a CAAHEP or ABHES accredited program and has passed the Certified Medical Assistant Exam of the American Association of Medical Assistants (AAMA).

An RMA is a registered medical assistant. The designation RMA indicates that a medical assistant has graduated from a CAAHEP or ABHES accredited program and has passed the Registered Medical Assistant Exam of the American Medical Technologists (AMT).

Medical Assistant Professional Organizations

Professional organizations serve the medical assistant field in many ways. For example, some are involved in program accreditation. Others are involved in certification of medical assistants. Most offer information on careers, and many offer professional development and continuing education opportunities.

ACCREDITING AGENCIES

The Accrediting Bureau of Health Education Schools (**ABHES**) is a private, nonprofit agency recognized by the U.S. Secretary of Education. ABHES was established in 1968. It is involved in the accreditation of medical assistants, medical laboratory technicians, and surgical technology allied health programs.

The Commission on Accreditation of Allied Health Education Programs (**CAAHEP**) is involved in the accreditation of allied health and health science programs. CAAHEP is recognized by the Council for Higher Education Accreditation (CHEA) and accredits more than 2,000 educational programs in 23 health science occupations.

The Commission on Accreditation of Allied Health Education Programs prints testimonials about the importance of school accreditation from educators in the medical assistant industry. CERTIFYING AGENCIES

The American Association of Medical Assistants (**AAMA**) was founded in 1956. It awards certification for medical assistants (CMAs). The American Medical Technologists (**AMT**) is a nationally and internationally recognized nonprofit certification agency. It is a professional membership society established in 1939. AMT offers certification opportunities to medical assistants, medical technologists, medical lab assistants, phlebotomy technicians, and other allied health professionals.

CONTINUING EDUCATION AGENCY

The AMT Institute for Education (**AMTIE**) is an agency for professional development. It is a separate nonprofit agency established by AMT in 1979 to assist AMT-certified members in maintaining their professional competence through continuing education.

Membership Benefits

Membership in professional organizations has many benefits. It is a reliable source of career information. Generally, professional organizations offer continuing education and professional development opportunities. In addition, membership can help you remain current with medical assistant duties, responsibilities, and continuing education requirements.

Some professional organizations offer job placement services, links to job opportunities, and job referral services. You will benefit from discounts on insurance, travel, and products. Pro-



fessional journals, periodicals, and newsletters will provide you with information and discounts on conferences, seminars, and workshops.

Membership can present networking and publishing opportunities. Some organizations offer funding or opportunities for grants and scholarships. In addition, professional associations often provide input into local, state, and national issues related to medical careers. They offer opportunities for legislative leadership and advocacy. Also, organization journals, periodicals, and newsletters may feature business advertising.
