2007 Condition of Education

Over the past five years Governor Blagojevich and the Illinois General Assembly have provided more than \$5.9 billion in new dollars to Illinois schools. This historic support has expanded access to high-quality preschool for at-risk three and four year olds, and raised the foundation funding level for each Illinois student more than 5.8 percent each year. In addition, these resources have supported pilot programs in class size reduction, technology immersion and teacher induction and mentoring along with programs focused on teacher recruitment and principal mentoring.

Learning Outcomes

The 2007 Report Card shows nearly 300 struggling schools placed on improvement status under No Child Left Behind are making significant progress. An analysis of the 2007 School Report Card shows that 184 schools and 36 districts have been removed from improvement status by making Adequate Yearly Progress for two consecutive years. In addition, the data also shows that 113 schools and 102 districts in improvement status will not advance to further sanctions because they have showed sufficient gains over the past two testing cycles.

The most recent statewide tests were given in March and April. Students in third – eighth grades took the Illinois Standards Achievement Test (ISAT) in reading and mathematics while students in fourth and seventh grades were tested in science and fifth and eighth grade students were tested in writing. Students in 11th grade take the Prairie State Achievement Exam (PSAE), which tests students in math, reading and science.

The statewide average percentage of students meeting or exceeding standards on ISAT increased from 77 percent in 2006 to 78.7 percent in 2007, while the average percentage of students meeting and exceeding standards on the PSAE fell from 54.3 percent last year to 52.6 percent this year.

The 2007 School Report Card offers a wealth of useful and important information for students, schools and districts, as well as parents and community members including overall student performance, as well as the shifting of student demographics.

Student Demographics

- Number of school districts declined from 898 in 1998 to 871 in 2007.
- Student enrollment in Illinois public schools increased from 1,951,998 in 1998 to 2,077,856 in 2007.
- Minority enrollment increased to 45.1 percent for 2007 compared to 37.5 percent in 1998. The increase is accounted for mainly by Hispanic students. Minority students are students who are Black, Hispanic, Asian/Pacific Islander, Native American or Multiracial/ethnic.
- Low-income students increased from 36.3 percent of the enrollment in 1998 to 40.9 percent in 2007.

Student Performance & Achievement

- Between 1999 and 2007, ISAT reading performance increased at grades 3, 5 and 8.
- ISAT mathematics performance increased at grades 3, 5 and 8 between 1999 and 2007.
- ACT Composite Score for public school students increased from 19.9 percent in 20.3 percent in 2007.

Information included in this year's School Report Card also indicates that the state's school dropout rate has decreased to 3.5% from 6.3% in 1998.








APPROPRIATIONS BY MAJOR PURPOSE

















FY07 State, Local and Federal Funding

A Profile of Illinois Public Schools in 2006-07 Selections from School Report Card Files (regular public schools only)

SUMMARY

TRENDS

Number of school districts declined: The number of operating school districts declined from 898 in 1998 to 871 in 2007; there were 376 elementary districts, 100 high school districts, and 395 unit districts.

Number of public schools increased: The number of public schools increased from 3,864 in 1998 to 3,888 in 2007. These figures include charter schools and regular public schools which issue report cards.

Increase in average school size: The average school size increased nearly 6% from 505 in 1998 to 534 in 2007.

Student enrollment continued to increase: Student enrollment in the regular Illinois public schools increased steadily from 1,951,998 in 1998 to 2,077,856 in 2007. In the last decade, student enrollment increased by 125,858 or 6.4%. Enrollment reported here only includes students in regular public schools.

Increase in low-income students: Low-income students increased from 36.3% of the enrollment in 1998 to 40.9% in 2006. Pupils are considered low-income if they are from families receiving public aid, are living in institutions for neglected or delinquent children, are being supported in foster homes with public funds, or are eligible for free or reduced-price lunches.

Mobility rate declined: The mobility rate declined from 18.2% in 1998 to 15.2% in 2007. The mobility rate is the sum of the students transferred out and students transferred in, divided by the average daily enrollment, multiplied by 100. A student may be counted more than once, depending on the number of transfers the student makes in a year.

Percent minority increased: Students who are Black, Hispanic, Asian/Pacific Islander, Native American, or Multiracial/ethnic make up 45.1% of the enrollment in 2007, up from 37.5% in 1998. The increase in minority percentage is accounted for mainly by increases among Hispanic students.

LEP students increased in the last decade: Limited-English Proficient (LEP) students increased from 6.2% in 1998 to 7.2% in 2007. LEP students include those who are eligible for bilingual education.

Decline in dropout rate since 1998: The dropout rate declined from 6.3% in 1998 to 3.5% in 2007. Dropouts include students in grades 9-12 whose names have been removed from the

district roster for any reason other than death, extended illness, graduation/completion of a program of studies, transfer to another school, or expulsion.

Slight increase in chronic truancy rate: The chronic truancy rate was 2.5% in 2007, compared to 2.3% reported in 1997. Chronic truants include students, subject to compulsory attendance, who have been absent without valid cause from such attendance for 10% or more of the previous 180 regular attendance days.

In the last decade, average class sizes declined at the elementary level and remained unchanged at the high school level: Between 1998 and 2007, the average class sizes for:

Kindergarten declined from 22.1 to 20.9

Grade 1 declined from 22.8 to 21.0

Grade 3 declined from 23.2 to 21.8

Grade 6 declined from 24.3 to 22.6

Grade 8 declined from 23.5 to 21.9

High School (grades 9-12) remained the same at 18.9

Minorities account for about 15% of the teaching force: While minorities account for 45.1% of the students enrolled, 14.9% of the classroom teachers are from minority groups.

Decline in the percent of male classroom teachers: There is a downward trend in the percent of male teachers, declining from 24.8% of the teaching force in 1998 to 23.0% in 2007.

Percent of teachers with graduate degrees increased slightly: In 2007, teachers who had a master's degree or above accounted for 52.3% of the classroom teachers in Illinois public schools, up from 46.3% in 1998.

Equal number of students per teacher at elementary and secondary levels in 2007: The elementary pupil-teacher ratio (PTR) declined from 20.0:1 in 1998 to 18.8:1 in 2007. The secondary PTR increased from 18.5:1 in 1998 to 18.8:1 in 2007. For the first time in the last decade, the elementary PTR and secondary PTR are equal.

Teaching experience (years) declined since 1998: The average teaching experience of Illinois public school teachers declined from 15.0 years in 1998 to 12.9 years in 2007. This declining trend may be a reflection of baby-boomer generation teachers retiring.

Average teacher salary increased by 33% since 1998: The average teacher salary increased from \$43,806 in 1998 to \$58,275 in 2007. When adjusted for inflation, the average teacher salary decreased by about 7% between 1998 and 2007.

Average administrator salary increased by 39% since 1998: The average administrator salary increased from \$73,423 in 1998 to \$102,310 in 2007. When adjusted for inflation, the average administrator salary decreased by about 3% between 1997 and 2006.

Between 1997 and 2006, statewide operating expenditure per pupil (OEPP) increased by 51%: The statewide OEPP increased by 51% from \$6,281 in 1997 to \$9,488 in 2006. After adjusting for inflation, the OEPP increased by about 9% since 1997.

Percentages of Types of New Certificates Issued Statewide 2006-07









Teacher's Retirement Systems

The purpose of these funds is to pay the statutorily required state share of the actuarial liability of the Teacher's Retirement System including the Teacher's Retired Health Insurance Program and to subsidize the Chicago Teacher's Retirement System, Public Act 88-593.

These funds are appropriated directly to the Teacher Retirement System and the Chicago Teacher's Retirement Fund. The following represent historical appropriation amounts as shown in the Illinois State Budget Books:
