Assessment

Update on English language assessment

If a student does not take the PSAE/PARCC or ACCESS for ELLs® during high school, how can the student demonstrate English proficiency for the purposes of the Seal or Commendation?

Because of the transition from the PSAE to PARCC in the 2014-15 school year, districts will have graduating seniors in the 2015-16 school year who did not take the PARCC or the PSAE in high school.

A student may use the results of a standardized assessment meeting the requirements of 1.442(a)(1), including the ACTFL Assessment of Performance toward Proficiency in Languages (AAPPL), TOEIC® or TOEFL® to meet the English proficiency requirement for the Seal or Commendation.

A district may choose to use the ACT or SAT college entrance test and determine the minimum score that students must attain to meet the English proficiency requirement defined by the State. The district must maintain evidence that the assessment meets the criteria specified for standardized assessments in 1.442 (a)(1)(A)(iii) and one of the sets of criteria for English proficiency listed in 1.442 (b) and make that evidence available to the State Superintendent of Education upon request.
