#### Success Story: Bensenville Elementary School District 2

Bensenville Elementary School District 2, a Race to the Top district, includes 62 percent low-income families and 33 percent of students with limited English proficiency. Having a diverse student body presents its own unique challenges, and Bensenville, like all districts, has been working diligently to improve their educational experience for all students. One of the ways the district has done this is **by adopting the Peer Assistant and Review Program (PAR), which, they've found,** has gone hand in hand with creating an effective educational environment. Bensenville has utilized communication to successfully implement peer evaluation. **They've cultivated a culture** of communication by keeping everyone, from the superintendent to consulting teachers to principals, informed and involved to foster a culture of collaboration for their PAR program. ## **The New Illinois Learning Standards**

The New Illinois Learning Standards in English Language Arts and Literacy are meant to build upon, not replace, existing standards. The goal is to prepare students to thrive not only in college, but in their careers as well. This involves teaching texts that increase in complexity and thereby providing the student the reading comprehension needed to succeed in their college and career lives. The New Illinois Learning Standards are not an attempt to rid the writing and reading curriculum of narrative, creative work, and fiction texts. Narrative writing is still expected to be in the curriculum; furthermore, literary texts and informational, non-fiction work should be taught with equal emphasis. The standards are also not about prescribing a reading list to schools; in fact, required reading lists are not a part of the standards intentionally. The New Illinois Learning Standards offer only a shared **destination; the roadmap used to get there, however, remains up to each district's** discretion.

# Race to the Top Districts Attend the Illinois New Teacher Collaborative (INTC) Conference

Thirteen RttT districts attended INTC's 10th Annual Induction and Mentoring (IM) Conference in Springfield the last week in February in order to gain new ideas for their New Teacher IM Programs. The day and a half of informational breakout sessions, powerful networking opportunities, and productive team work time resulted in a positive and beneficial experience for RttT district teams and afforded them the opportunity to begin moving their programs into the next level of implementation. The RttT session on February 25 offered districts the opportunity to share and discuss strengths and areas for growth around the nine IM Program Standards, collaborate in order to maximize resources, and ask questions pertaining to the RttT expectation for Induction and Mentoring. To top it off, several RttT districts attendees won some terrific prizes such as books, free conference registration for next year, and an IPad at the closing luncheon.
