School Nutrition Programs Meal Compliance and Accountability Review

This report summarizes the results of the meal compliance and accountability review for the School Nutrition Programs sponsored by the Dunlap CUSD 323, RCDT number 48-072-3230-26, conducted on March 6, 7, 8, 2023, by Harley Hepner, Principal Consultant.

During the review, the following problems were identified. All other areas were found to be in compliance.

Site: Dunlap Middle School (14450)

Meal Components and Quantities

Citation:

On the day of the lunch observation, the portion size of the carrots in the grab-n-go meal option did not meet meal pattern requirements. The minimum serving size of the vegetable must be 3/4 cup daily for grades K-8.

Citation:

The lunch menus for the selected week of review, January 23-27, 2023, were evaluated and it was determined the minimum vegetable serving size was not offered on Monday through Friday with the grab-n-go meal option. A minimum of 3/4 cup vegetable must be offered on a daily basis for each meal option for grades K-8.

Meal Components and Quantities

Citation:

Lunch menus for the selected week of review, January 23-27, 2023, were evaluated and the following problems were identified:

1) The weekly minimum meat/meat alternate ounce equivalents were not offered with the smallest creditable meal option (chickpea spread) offered each day of the week. Menus must contain a minimum of eight meat/meat alternate ounce equivalents per week for grades K-8 regardless of the meal option chosen.

2) The minimum weekly portion requirement was not met for the beans/peas (legumes) vegetable subgroup. The minimum weekly portion requirement must be met for each vegetable subgroup.

Benefit Issuance Documents

Citation:

Adequate documentation was not on file for a foster child because legal documentation and/or other documentation was not available to support that the child was a foster child. Current legal documentation for foster children must be obtained from court, DCFS, or a foster care agency.

Citation:

Adequate information was not given to households approved through Direct Certification. The notification did not ask for additional students in the household that may be eligible through the extension of benefits. Notification to households of approval through Direct Certification must contain the required information.
