Does CPS's electronic IEP system, either alone or in conjunction with CPS's Policies and Procedures, result in an unlawful denial or delay of required services or limitations on the required continuum of services to students?
Do CPS's documentation and data collection requirements result in unlawful denial or delay in the identification of eligibility or provision of special education and related services to students?
Does CPS's budgeting system result in unlawful denial or delay in the provision of special education and related services to students?
Have CPS's policies regarding transportation resulted in an unlawful denial or delay in the provision of needed transportation services to students?

All interested Third Parties will be asked upon arrival, to sign in, and will be called in the order in which they arrive and sign in. Should you not be in the designated waiting area when your name is called, you will forfeit your right to provide Community Input.

The Inquiry Team will meet privately with each individual from the community who wish to be heard. Individuals will be limited to no more than <u>5 minutes</u> for their presentation. Individuals will also be afforded the opportunity to prepare and submit Affidavits on that day. Affidavits submitted by these individuals will be shared with the Parties in accordance with the Standard Operating Procedures, and considered by the Inquiry Team in the same manner as other Affidavits.
