During the previous school year some of Gordon Bush challenges were with having teachers plan effective, providing adequate support for all teachers, using data to support student achievement, improving test scores on local and state test as well as high suspension rate for students.For the first quarter of the year the Gordon Bush behavior team has put systems in place that would allow data to be collected and used to help make decisions as it relates to incentives and program the Behavior Team will offer. As the systems were put in place and become better understood, initiatives were implemented and we began having success with the student's behavior changing. Students that are involved in Character Education and BAG's program have shown tremendous improvement in their behavior. As a result these two groups of students have shown a decrease in the number of referrals for the quarter which contributes to a significant drop in the number of referrals received overall in the school. These students have been a part of a structured program that focuses on developing behavior and utilizing strategies to help deal with challenging situations. The team has taken an aggressive and proactive approach in dealing with student's behavior. Along with a consistent PBIS structure, the behavior team has incorporated a mix of parental conferencing, restorative circles, character education, check-in check-out, observations, attendance incentives by class, and self-reflection to assure students are receiving the maximum support to facilitate good behavior. Students are starting to open up and discuss personal feelings and concerns. Students are more willing to report concerns an about other students. Students are more respectful to each other and staff and visitors. Students that are receiving support from behavior team have shown improvement in the amount of behavior referrals received. The behavior team has become a recognizable resource for challenging situations.Data shows that our efforts have contributed to drastic decreases in incidents that require behavior referrals. Between the dates of August 22nd and Sept. 9th there were 38 referrals written. Students that have been identified for Character Education and BAG's received 24 (63%) of those. Character Education and BAG's began the week of Sept. 9th. Since then, we have received 45 referrals in which the student's receiving intervention received only 16 (35%). This 44% decrease is an indication that the program and initiatives are successful Professional Development provided this quarter involved data analysis of ESGI testing to determine Literacy Island attendance, along with activities to support growth in individual classrooms. The Lead Partner literacy consultant Donna Whyte provided ongoing support for Daily 5, Student Engagement and Classroom Management. Focus was provided that targeted Personal Learning Communities and Peer-to Peer collaboration. Consulting was provided within Team Leadership meetings along with Personal Meetings with Administration to address immediate needs of classrooms that focused specifically on Domains 1 & 2 of the Charlotte Danielson's Model. Work on Literacy Island and The Model Classroom continues to ensure that each will support staff and children in Literacy. ESGI data was aligned with the 4th Grade NWEA scores to ensure consistency in support. Individual student data and classrooms were analyzed to determine the level of support that Literacy Island team members could provide as both "push in" and "pull out", dependent upon data. Literacy Island houses two reading teachers, one paraprofessional, and one PCG tutor to provide intense reading instruction to students. The math professional development at Gordon Bush Elementary School for quarter one of the FY 2016-2107 school year was performed by Annmarie Garcia, Lead Partner math consultant. The goal is for Gordon Bush Elementary math teachers to provide a mathematics learning environment that will be motivating, challenging, and meaningful for all their students. After a week-long Educator's Symposium August 8 - 12, 2016, the Gordon Bush Elementary math teachers began the FY 2016-2017 school year with the goal of evaluating their grade level teaching by looking at their grade level math domains using the document "Where to Focus" by Grade Level Mathematics created by Achieve the Core. A daily math lesson at Gordon Bush Elementary consist of the following components: Do Now, Math Talk, Daily Lesson and Center activities During the PLC meeting, teachers are collaborating and receiving extensive professional development on two of the components of a math lesson, math talks and center development. Each teacher has been provided a copy of the book, TIME'S Up on Timed tests by Kristin Hilty and Eliza Sorte-Thomas, 2017 The Gordon Bush Elementary math coaches and the consultant, Annemarie Garcia, collaborate at least 30 minutes weekly about what is expected in the math lessons. The district's math area content specialist and math consultant collaborate at least twice a month on items relating to the district math needs especially at Gordon Bush Elementary.As of October 10, 2016, 100% of the math teachers were on target with the district's math assessment calendar. Listed below are the Worthy Targets of Elementary Mathematics as designed by the East Saint Louis math content specialist, Mrs. Kay Rhodes-Brown. These worthy targets are used as a guide for teachers to develop unit of mathematics study along with the Math in Focus units. Teachers are asked to include as many of these targets as possible in a unit of study Based on NWEA scores, the first grade students demonstrated the most improvement (K Spring 2016-Fall 2016), Projected Growth for this group was 26.0 and the observed growth was 18.0. The least amount of growth was shown in 4th grade. Projected Growth was 10.4 and observed growth was 9.4 Overall, Females perform better than males.The current PARCC data indicates that females out -performed males in ELA. Listed below are the levels of performance areas for 3rd grade ELA.PARCC Data 3rd Graders (Spring 2016):Level 1- 63 students did not meet (65.6%)Level 2 - 16 partially met (16.7%)Level 3 -13.5 Approached Expectations (13.5%)Level 4 - 3 met expectations (3.1%)

In order to support our new reading initiatives, we have a full time instructional coach that will support English Language Arts and Social Science and Science in strengthening and implementing Best Practice reading strategies within these contents. We have added the following: two reading specialist, two paraprofessional and one academic interventionist that all provide small group instruction in foundational deficit areas of English Language Arts. Literacy Island will service grades K-2 & 4 (tier II and III students) for 45 minutes in ELA instructional support for these students. Literacy Island is staffed with 2 reading teachers, one paraprofessional, and one PCG tutor. Kindergarten is receiving daily support, 1st-2nd is receiving support 3 to 4 times per week and 4th grade receives daily push-in support.All ELA teachers receive support from the administration, instructional coach and academic interventionist on best practice instructional strategies. Teachers are provided feedback and encouraged to make instructional changes as needed. All ELA teachers participate in weekly PLC's to receive training, discuss data, or collaborate on strategies to improve instruction and delivery. The academic interventionist will provide services to 3rd grade in the area of reading. This support is provided in small group (tier III students), 40 minute daily increments. 21st Century After-School Program is providing Corrective Reading for grades 2nd -4th. This program provides 1 hour of reading instruction for 4 days a week. Each classroom has its own chrome cart to support technology in the ELA content area. An instructional math coach and math consultant were added to the staff to assist teachers with planning and preparation, modeling, providing resources and on-site professional development that support best math practices. Teachers are receiving weekly professional development on best practices and strategies in math which they can immediately take back to their classrooms to implement. They are planning weekly with instructional coaches and teams to

ensure that they are intentionally planning their instructional around lesson objectives. The Instructional Coaches are also using PLC's to assist teachers with looking at their classroom data in order to plan lessons that will provide optimum results. All grade eveled teachers are currently using their NWEA data to assess objectives where students need extra support. They are looking at the standards to ensure that their math centers and the RTI period (extra 30 minutes) activities are addressing these deficiencies. Our Tier 2 fourth grade students are receiving extra support from Math in Fellows in the Math in Motion Lab. Students are getting a double dose of instruction, as well as reinforcement of skills that are essential to move ahead within their daily curriculum. The Math Fellows are also pushing into the fourth grade classrooms to offer additional support to the Tier 1 and Tier 3 students, daily. The Academic Interventionist is also pushing into third grade, daily, to offer support to all students. The Blueprint Math Fellows Program (Math in Motion Lab) is an intervention program designed to bridge gaps in student education, specifically in mathematics.Interventions in place:Small group instruction (4:1 student - fellow).Extra 45 math minutes (during Encore minutes) for enrolled students - Math in Motion is in addition to core instruction.Data driven instruction - differentiation and groupings based on skills, lesson plans designed to meet the needs of students at their Zone of Proximal Development.Number Talks to build mental math skills and analysis of other's work, justification of strategy selection and use. Starting with 2nd Quarter, Gordon Bush Elementary will implement Math Journal Writing and Exit Tickets with fidelity across the math curriculum. - 1. The applicant has the necessary legal authority to apply for and to receive the proposed award. The filing of this application has been authorized by the governing body of the applicant, and the undersigned representative has been duly authorized to file this application for and on behalf of said applicant, and otherwise to act as the authorized representative of the applicant in connection with this application and any award in relation thereto.

The applicant affirms, under penalties of perjury, that he or she is authorized to execute these Certifications and Assurances, and Standard Terms of the Grant on behalf of the applicant. Further, the applicant certifies under oath that all information in the grant agreement is true and correct to the best of his or her knowledge, information and belief, that grant funds shall be used only for the purposes described in this agreement, and that the award of this grant is conditioned upon this certification.

DEFINITIONS

"Applicant" means an individual, entity or entities for which grant funds may be available and has made application to the Illinois State Board of Education for an award of such grant funds.

"Award recipient" means the person, entity or entities that are to receive or have received grant funds through an award from the Illinois State Board of Education. The terms "grantee" and "award recipient" may be used interchangeably.

"Expenditure through dates" are from the project beginning date through September 30, December 31, March 31, and June 30 of each fiscal year and the project ending date.

"Grant" means the award of funds, which are to be expended in accordance with the Grant Agreement for a particular project. The terms "grant," "award," and "project" may be used interchangeably.

"Project" means the activities to be performed for which grant funds are being sought by the applicant.

The capitalized word "Term" means the period of time from the project beginning date through the project ending date.

PROJECT

- 2. The project proposed in the application, and as negotiated and finalized by the parties in the Grant Agreement, is hereinafter referred to as the "project." In planning the project there has been, and in establishing and carrying out the project, there will be (to the extent applicable to the project), participation of persons broadly representative of the cultural and educational resources of the area to be served, including persons representative of the interests of potential beneficiaries.
- 3. Applicants may be asked to clarify certain aspects of their proposals/applications prior to final agreement on the terms of the project.
- 4. All funds provided shall be used solely for the purposes stated in the approved proposal/application.
- 5. The project will be administered by or under the supervision of the applicant and in accordance with the laws and regulations applicable to the grant. The applicant will be responsible for and obtain all necessary permits, licenses, or consent forms as may be required to implement the project.

SUBCONTRACTING

6. No subcontracting is allowed under this project, except as set forth in the Grant Agreement.

FINANCIAL TERMS

- 7. Payment under this grant is subject to passage of a sufficient appropriation by the Illinois General Assembly or sufficient appropriation by the U.S. Congress for federal programs. Obligations of the Illinois State Board of Education will cease immediately without further obligation should the agency fail to receive sufficient state, federal, or other funds for this program.
- 8. An applicant must not obligate funds prior to the start date of the project set forth in the final Grant Agreement. The project's start date cannot precede the start of the fiscal year for which the funds are appropriated.
 - All project activities must be completed between the project beginning date and the ending date (the "Term"). Liquidation of all obligations, including the current year's audit fee, should be completed no later than ninety (90)calendar days after the project ending date.
- 9. The applicant understands that payment for approved services and expenses will be made on a cash needs basis, and that payment will be made in accordance with applicable statutes, regulations, and standards after an application for payment is submitted to the Illinois State Board of Education. Vouchers for payment will be submitted to the Office of the Comptroller according to the payment schedule attached to the final Grant Agreement. The payment schedule shall be based on the projected date of expenditures. Payments will be withheld from scheduled amounts if expenditure reports show excess cash on hand.
- 10. An approved budget may be amended by completing the Budget Summary form to show the new amounts required and attaching an explanation for the changes. An amendment to the Grant Agreement must be entered into whenever any individual cell changes by more than \$1,000 or 20 percent, whichever is larger. An amendment to the Grant Agreement must also be entered into whenever an award recipient proposes to use funds for allowable expenditures not identified in the currently approved budget, if the scope of the project is expected to change, or if the overall grant award must be increased.
- 11. Obligation of funds for items or services based on amendments cannot be encumbered prior to the date of receipt at the Illinois State Board of Education of a substantially approvable budget amendment provided the scope/intent of the approved project has not changed. If the scope/intent of a project changes based on an amendment, programmatic approval must be obtained prior to the obligation of funds based on the amendment. Expenditure reports are due twenty (20) calendar days after the expenditure through date. Failure to file the required reports within the timelines will result in a breach of the Grant Agreement. Upon any such breach, the Illinois State Board of Education may, without limitation, withhold the current year's payments and payments for future years' projects under the same program until the reports are properly filed.

All grant funds must be spent or obligated, and all activities must be completed prior to the project ending date. Each award recipient must submit a completion report showing the obligations and the expenditures for the project no later than twenty (20) calendar days after the project ending date.

If a completion report was filed through the project ending date and had no outstanding obligations, the completion report will be the award recipient's final expenditure report. Failure to submit this completion/final expenditure report will result in current and subsequent years' project funding being withheld until the report is received. In cases where final expenditures are less than total disbursements, the overpayment must be returned to the Illinois State Board of Education within forty-five (45) calendar days of the project ending date for all state grants or federal grants that do not expressly allow carryover funds. Failure to return the funds will result in a breach of the Grant Agreement. Upon any such breach, the Illinois State Board of Education may, without limitation, withhold current and subsequent years' project funding until the overpayment is returned.

If a completion report was filed with outstanding obligations, then a final expenditure report showing total project expenditures (with all prior obligations paid) must be submitted no later than ninety (90) calendar days after the project ending date. NO BINDING OBLIGATION

17. The applicant acknowledges and agrees that the selection of its proposal for funding, or approval to fund an application, shall not be deemed to be a binding obligation of the Illinois State Board of Education until such time as a final Grant Agreement is entered into between the applicant and the Illinois State Board of Education. Prior to the execution of a final Grant Agreement, the Illinois State Board of Education may withdraw its award of funding to the applicant at any time, for any reason.

COPYRIGHT

18. All rights, including copyright to data, information and/or other materials developed pursuant to an award, are retained by the Illinois State Board of Education, unless otherwise agreed in writing by the Illinois State Board of Education. All such work products produced by the award recipient through work pursuant to the award shall be made available to the Illinois State Board of Education upon request.

DEFAULT AND TERMINATION

19. The award recipient will be in default of the grant award and the corresponding Grant Agreement if it breaches any

representation or warranty made in the Grant Agreement, the Program-Specific Terms or in these Certifications and Assurances, and Standard Terms of the Grant, or fails to observe or perform any covenant, agreement, obligation, duty or provision set forth in the Grant Agreement, the Program-Specific Terms or in these Certifications and Assurances, and Standard Terms of the Grant. Upon default by the award recipient and written notification by the Illinois State Board of Education, the award recipient will have ten (10) calendar days in which to cure the default to the satisfaction of the Illinois State Board of Education. If the default is not cured to the satisfaction of the Illinois State Board of Education, the Illinois State Board of Education shall thereafter have full right and authority to terminate the Grant Agreement and/or seek such other remedy that may be available at law or in equity. Upon termination of the Grant Agreement, the award recipient will cease all use of grant funds, shall cancel all cancelable obligations relating to the project, and shall return all unexpended grant funds to the Illinois State Board of Education within forty-five (45) calendar days of termination.

INDEMNIFICATION

20. Further, no award recipient shall deny access to the program funded under the grant to students who lack documentation of their immigration status or legal presence in the United States (Plyler v. Doe, 457 U.S. 202, 102 S.Ct. 2382 (1982)).

Any applicant not subject to Section 10-21.9 of the School Code certifies that a fingerprint-based criminal history records check through the Illinois State Police and a check of the Statewide Sex Offender Database will be performed for all its a) employees, b) volunteers, and c) all employees of persons or firms holding contracts with the applicant, who have direct contact with children receiving services under the grant; and such applicant shall not a) employ individuals, b) allow individuals to volunteer, or c) enter into a contract with a person or firm who employs individuals, who will have direct contact with children receiving services under the grant who have been convicted of any offense identified in subsection (c) of Section 10-21.9 of the School Code (105 ILCS 5/10-21.9(c)) or have been found to be the perpetrator of sexual or physical abuse of any minor under 18 years of age pursuant to proceedings under Article II of the Juvenile Court Act of 1987 (705 ILCS 405/2-1 et seq.).
