



What is Continuous School Improvement?




Collaborative process through which staff and education partners identify strengths and weaknesses of the entire school program.



Use the information as a basis for making deliberate, positive, cohesive, and observable changes in measurable student outcomes.

Statewide Framework for Success



What is the School Improvement Grant and what can I spend my grant dollars on?

Build the capacity of school leaders to implement and sustain effective school improvement practices.



Comprehensive funds will be utilized to pay for the school-level needs assessment conducted by the American Institute for Research (AIR).

Targeted and Comprehensive might spend grant dollars on compensating staff to work on school improvement plans, reviewing data, conducting vertical and horizontal curriculum articulation activities, paying for an approved learning partner, releasing staff for collaborative planning time and various curriculum materials and supplies.






ESSA Requirement for Resource Allocation Reviews

The Every Student Succeeds Act requires State Education Agencies to conduct Resource Allocation Reviews (RARs) with districts that operate a significant number of schools identified for school improvement status via the [Illinois Accountability System](#) ([§1111\(d\)\(3\)\(A\)\(ii\)](#)).

These RARs provide an opportunity for district and school leaders to collaboratively explore current resource allocation practices with ISBE's support.

ISBE selects districts based on the number and percentage of schools in a district that are identified for Intensive, Comprehensive, or Targeted support.

Standards of Effective Resource Allocation

An effective resource allocation system will have the following properties:

- **Equitable:** Provides resources based on the needs of students and schools such that those with higher needs receive additional resources.
- **Transparent:** Provides resources through a simple, well-defined, and clearly documented process such that stakeholders understand how resources are allocated to schools and how resource levels are differentiated.
- **Engages stakeholders:** Allows for input in the budgeting and planning process from various education stakeholders, such as school site leaders and staff, parents, and community members.
- **Aligns with district goals and priorities:** Integrates and aligns with planning and school improvement processes, focuses on improving student outcomes, and offers flexibility to be responsive to new or shifting goals and priorities.

RAR Structure

Before

- Intro call - program goals, participants, timelines
- Collect and review evidence of practice
- Share data report and protocol with district


During

- Discussion of evidence (provided by district) and data (provided by ISBE)
- Support evaluation of current practice relative to standards

After

- Summary report and resources
- Connect districts to technical assistance aligned with areas of need

Requirements for All Schools in Improvement Status

Targeted Comprehensive

- Rest of State: Complete the Illinois Quality Framework Supporting Rubric; Chicago Public Schools: Complete Foundations
- Use additional data to complete a school level needs assessment
- Identify resource inequities
- The School Improvement Plan includes at least 2 academic student goals
- Evidence-based practices are selected
- The School Improvement Plan is approved by the local Board of Education

Additional Requirements for Comprehensive Schools

Comprehensive Support and Improvement

- All previous requirements plus,
- School-level needs assessment with AIR
- The School Improvement Plan is approved by the local Board of Education and by ISBE
- The School Improvement Plan is monitored by the LEA and ISBE



School Improvement  is a continuous, collaborative process through which staff and stakeholders identify strengths and weaknesses of the entire school program and use the information as a basis for making deliberate, positive, cohesive, and observable changes in measurable student outcomes.



The Statewide System of Support focuses resources on the schools and districts with the greatest need to build the capacity of school leaders to implement effective school improvement practices. The goal is to enable schools in improvement status to improve student outcomes and exit status.






Comprehensive School -

- Overall performance in the bottom 5 percent of Title I-eligible schools statewide
- All high schools with a graduation rate of 67 percent or below
- Schools that have completed a full Targeted Support school improvement cycle, where the performance of one or more of the originally Targeted student groups remains at or below the level of the "all students" group in the lowest-performing 5 percent of Title I-eligible schools at the end of the four-year improvement cycle

ESSA REQUIREMENTS FOR TARGETED SCHOOLS

LEAs must in partnership with stakeholders, including school leaders, teachers, and parents, develop and implement an improvement plan that:

- Is based on a school-level needs assessment.
- Includes goals to improve student outcomes.
- Includes evidence-based practices.
- Identifies resource inequities.
- Is approved annually by the school, district, and local board of education.
- Is monitored and periodically reviewed by the LEA.

Checklist for Getting Started

Now that your school has received a targeted designation, your school is required to begin a four-year improvement cycle. During these four years, you will focus on building and/or modifying the systems needed to improve student achievement and performance outcomes and to exit status. Below are the first steps you should take to begin your school improvement work.

- Be responsive to communication from your assigned School Improvement Coordinator. Review your calendar and be prepared for an initial 60–90-minute meeting.
