Lawrence School District will supply any materials/textbooks for any coursework not available at Ruth Connell Academy. Lawrence School District has confirmed that Ruth Connell Academy conducts quarterly benchmark assessments to all students who are of approximately the same age.

Ruth Connell Academy will supply the student's attendance and facility enrollment data monthly on the last day of the month via email. Attendance information is also available on the student portal which the district and parents can access online.

Lawrence School District assures that while placed at Ruth Connell Academy, Rowena will receive targeted support in mathematics through individualized instruction provided by a certified special education teacher. Instruction will be aligned with IEP goals and objectives, using evidence-based strategies and accommodations to ensure access to grade-level content and skill development. Rowena will receive weekly social work sessions conducted by a licensed school social worker. These sessions will address social-emotional goals, coping strategies, and behavioral supports as outlined in the IEP. Rowena will also have access to as needed check-ins 24 hours per day with a licensed counselor. Daily nursing services will be provided by a

registered nurse to provide medication administration and health monitoring. All services will be documented and monitored to ensure compliance with the IEP. Collaboration among staff—including educators, service providers, and administrators—will be ongoing to support the child's progress and well-being. Ruth Connell Academy is dedicated to maintaining a safe, supportive, and inclusive environment that promotes the child's academic, social, and emotional growth in accordance with their IEP.

5. The residential facility demonstrates that the facility is providing special education services itself per the requirements of 23 Illinois Administrative Code 226.330(g), which states "I school district may place a student in a nonpublic special education facility "facility" providing educational services..."
