End of FY 2023 IDEA requisites

As a reminder, we are encouraging every district to make sure the following end of fiscal year 2023 Individuals with Disabilities Education Act (IDEA) requisites have been completed.

IDEA Consolidated

Make sure FY 2022 Carryover is budgeted and expended. If the total amount of FY 2022 carryover is not expended by the end date of the grant, funds will be returned to the federal government. Please check the [Financial Reimbursement Information System](#) to ensure the carryover amount is expended for IDEA Part B Flow Through, Preschool, and Coordinated Early Intervening Services.

Final amendments are to be submitted no later than 30 days prior to the end of the district's fiscal year. Applications will be locked and changes will not be accepted after this time.

- May 30, 2023, for June 30, 2023, end dates
- August 1, 2023, for August 31, 2023, end dates

IDEA Excess Costs

The Excess Cost application was due **March 1, 2023**. Districts must have their Annual Financial Report (AFR) submitted to ISBE. AFRs should be used to complete the Excess Cost requirement. Audited information is preferred, but not required. Submission of the Excess Cost application is required to avoid putting the district's IDEA funds at risk of being frozen or being returned.

Comprehensive Coordinated Early Intervening Services (CCEIS)

Districts with significant disproportionality must budget and expend all of the allotted funds (15% of Flow Through and Preschool funds) in the IDEA Part B Flow Through application to support the district's CCEIS Action Plan.

FY 2022 ARP-IDEA (for districts that submitted prior to June 30, 2022)

Final amendments should be submitted no later than **May 30, 2023**. Applications will be locked and changes will not be accepted after this time. Final expenditure reports are due **July 20, 2023**.

Districts that have not obligated all of the IDEA ARP funds by **June 30, 2023**, will be required to complete an FY 2024 application to expend the carryover. The FY 2024 grant will end on **September 30, 2023**.

FY 2023 ARP-IDEA (for districts that submitted *after* June 30, 2022, or have *not* submitted)

If a district does not have an approved FY 2023 ARP-IDEA application, one must be submitted as soon as possible or there is a risk of losing this funding. This application will remain open and not require an FY 2024 application.

GATA Grant Periodic Reporting System (IDEA Consolidated & ARP-IDEA)

- Confirm **all** Grant Periodic Reports (GPRs) have been submitted for **all** fiscal years. This is a GATA requirement!
- GATA required quarterly reports prior to FY 2022.
- GATA required semiannual reports in FY 2022.
- GATA requires annual GPRs beginning in FY 2023. *These are due July 31, 2023.*

Make sure the [Periodic Performance Reporting](#) form has been uploaded before submitting the district GPR in IWAS.
