The 2023-24 school year is starting, so we'd like to take this opportunity to provide you some critical information about the assessment requirements in the Illinois Invest in Kids Act (IIKA) program. In particular, please note important information about the establishment process and testing windows.

## **FAQ for Principals and Test Coordinators**

An <u>FAQ</u> has been published on the ISBE IIKA webpage. You can find answers to general questions regarding IIKA and assessments in that document.

#### **Establishment Survey 2023-24 School Year**

The Establishment Survey, which is now open, is in the <u>IWAS system</u>. It is prepopulated with information submitted in last year's survey and from ISBE's Entity Profile System (EPS). You will be asked to verify and/or make the appropriate corrections to names, email addresses, etc. Once you submit it, you do have the opportunity to go back and make changes as long as the survey is up and running. The survey will remain open until Nov. 30, 2023.

All nonpublic schools that currently have or anticipate having Illinois Invest in Kids Act scholarship recipients in Grades 3-10 must fill out the Establishment Survey to establish the school as a testing site for the Illinois Assessment of Readiness, Illinois Science Assessment, and PSAT 8/9 and PSAT 10.

College Board will send an Establishment Survey regarding Grade 11 students only to high schools in September. High schools may have to fill out two Establishment Surveys -- the one for Grades 9 and 10 and the one from College Board for Grade 11 students.

The establishment survey also asks for an estimate of how many IIKA students in Grades 9 and 10 will be taking either the PSAT 8/9 and/or PSAT 10. If your school is planning to test all Grade 9 and/or Grade 10 students, please include those numbers in the boxes, as requested.

Please make any changes in the top section of the survey pertaining to a school's name, address, phone number, etc. in the Entity Profile System if the information displayed is incorrect. The changes made in EPS should take effect the following business day.

If you need help while in the IWAS system, please click the "Help" button on the main page. An <u>IWAS User's Guide</u> also is on the IWAS main page for reference, should you have any issues.

# SAT w/ Essay, PSAT 8/9 and PSAT 10

All College Board-required testing for IIKA scholarship recipients is to be given within a six-week testing window this year. The testing window will be March 18-April 26. All testing must be completed within the testing window. No testing or make up tests will be available beyond April 26. All IIKA scholarship recipients in Grades 9, 10, and 11 are required to test during the spring 2024 testing window.

If you would like to test all your students during the spring 2024 testing window, please feel free to do so and place your order with College Board when the ordering window opens later this school year for spring 2024.

Please note that all testing costs are paid for by the qualified nonpublic schools, per the <u>IIKA</u>.

# \*NEW\* Online College Board Testing for 2023-24

College Board will move to a fully digital testing platform for the SAT w/ Essay, PSAT 8/9, and PSAT 10 for the 2023-24 school year so it is important to take notice and plan appropriately for how your school will administer such tests in the next school year. College Board has stated that there will be very few exceptions to continue the use of paper testing. Please keep this in

# **Science Testing Results**

All students that took the Illinois Science Assessment (ISA) will have a complete score in the fall of 2023. Scores will be delivered to the individual schools. Schools will also be able to access ISA scores via IWAS. Notification will be sent to all schools when the scores become available.

## IAR (Illinois Assessment of Readiness) Testing Results

Results from the IAR are now available! IIKA schools have access to OnDemand reports. To access these scores:

- Go to Pearson PAN and log in.
- Select "Reports" and choose "OnDemand" in the dropdown.
- You can choose a Student Detail Score, which is a one-page PDF for each student and each test. This report also includes a Lexile and Quantile score for each student.
- You can also choose a Student List Report, which will provide all student scores in an Excel file. You will need to add Lexile and Quantile Reporting by choosing them in "Manage Columns."
