Dear School Administrator,

The assessments for the 2022-23 school year that were required by the Illinois Invest in Kids Act (IIKA) now have been completed. A special thank you goes out to all the schools that completed the testing of their IIKA students! This month's newsletter will highlight when scores will be reported and how to gain access to your student scores.

HIGH SCHOOLS

SAT, PSAT 8/9, and PSAT 10

Students who took the March SAT w/ Essay test and who have a College Board account set up should have -- or soon will be receiving -- their scores. Students who tested on April 12 or the April 25 makeup date will receive their scores beginning in mid-May.

PSAT 8/9 and PSAT 10 test results for students will be available near the end of May.

Educators will receive their students' SAT w/ Essay, PSAT 8/9, and PSAT 10 scores near the end of May or early June

NEW Online College Board Testing for 2023-24

College Board will be moving to a fully digital testing platform for the SAT w/ Essay, PSAT 8/9 and PSAT 10 for the 2023-24 school year so it is important that you take notice and plan ahead. Please be on the lookout for College Board training offerings and a preview of the 2023-24 testing season. College Board has stated that there will be very few exceptions to continue the use of paper testing. Please keep this in mind when planning for the upcoming school year.

GRADE SCHOOLS

ISA Testing Results

All students that took the Illinois Science Assessment (ISA) will have a complete score in the fall of 2023. All tests had a written component, which must be scored by human scorers.

IAR Testing Results

OnDemand testing reports are the only scores that IIKA schools will have access to. This report will include a scale score and "meets," "exceeds," and "does not meet" expectations as compared to the national norm. This report will be available near the end of May. Log in to your Pearson PAN account, select "Reports," and choose "OnDemand" in the dropdown menu. Once

that page opens, select "Print," then choose Student List Report CSV or Excel. After about 30 seconds to a minute, the report should pop up in the field above the "Print" button. At this point, you can download the report or manage it for online use, however you choose.

ALL SCHOOLS

Testing Audit Upcoming

All testing commenced on Friday, April 28. An audit will be sent to each school to determine reasons why student(s) did not test.

If you did not get a chance to test your student(s), An audit will be sent to each school asking for reasons why the student(s) did not test. This audit will be sent out near the end of May or beginning of June. It will be a secure Excel file that is password-protected.
