Welcome to the Report Card Rundown -- A monthly data newsletter that outlines all of the Report Card data information districts need to know, including data system openings and closings, deadline reminders, key information regarding changes and updates to the upcoming Report Card, and how districts and schools are using Report Card to ignite conversations!

Need to Know

The 2018 Report Card will share a school's overall assessment proficiency rate. Historically, proficiency (or percentage of students meeting and exceeding standards) has been shared based solely on the state assessment administered that year. However, some special education students take an alternative assessment known as Dynamic Learning Maps (DLM-AA). Reporting on proficiency by assessment separates special education students' performance from their peers. Using an overall proficiency calculation is more concise and more inclusive. The overall assessment proficiency rate in the 2018 Report Card will include both the 2017-18 state assessment and the alternative assessment.
