IHE Direct Phone Line

The Center for Educator
Effectiveness will no longer have a direct phone line for institutions of higher education. Licensure officers and institution representatives are encouraged to contact their assigned liaison.

Out-of-State Test of Basic Skills

For candidates that come to an Illinois IHE that have taken an OOS test of basic skills, it may be honored if used for licensure in another state. Please advise the candidate to create an ELIS account, complete form 80.02 or form 80.03 whichever is applicable.

As a licensure officer, you may scan in the form and then simply email your ISBE liaison to notify them the documentation has been uploaded. Your ISBE liaison will review and upload the test into the testing section of the candidate's ELIS account.

LEGISLATION/RULE

Senate Bill 2912

Proposed by the Illinois State Board of Education on February 18, 2016, this bill has many changes that affect both Illinois prospective, current and out-of-state (OOS) educators who seek Illinois licensure. The following are highlights of the changes that became effective January 6, 2017. A complete summary can be found here.

- All tests are valid indefinitely
- Content tests taken in another state or country will be honored if required for licensure
- ELS-PEDU issued with OOS license and bachelor's degree
- (New) Provisional In-State
 Educator: An ELS-PEDU may
 be awarded to an individual who
 has completed an Illinois
 approved teacher education
 program, but has not yet passed
 the edTPA. It is valid for one
 year (full fiscal year), and
 cannot be renewed.

Educator must:

- hold a bachelor's degree,
- passed the test of basic skills,
- passed the appropriate content test, and
- receive a minimum edTPA score (yet to be determined).
- New fee for Substitute license-\$50.00
- Teacher Leader Endorsement: In lieu of required coursework, educators may be eligible to demonstrate competencies. Competencies are generally demonstrated through experiences.
- Prorated professional development required for renewal for retired educators

23 Illinois Administrative Rule

Rules implemented August 9, 2016 have impacted the requirements for program changes and approval, ultimately affecting the format of program proposals. All program proposal documents have been revised to reflect the rule changes and posted here. A summary of the changes to Part 25 are highlighted below. Click here for Rules currently in effect.

Part 25, Section 25.110: Definitions

 A definition for Council for Accreditation of Educator Preparation [CAEP] definitions was provided.

Part 25, Section 25.115: Recognition of Institutions and Educator Preparation Providers

- Recognition of an institution automatically results in recognition of the educator preparation provider (EPP)
 - Previously known as the "unit" under NCATE
- Not-for-profit institutions need to meet the definition of "institution" in Rules
- Revised Process for Institution Recognition (summarized below):
 - Institution submits letter notifying intent to seek recognition
 - Institution submits institutional report (IR) to ISBE (all previous reports have been combined into one).

- Institution submits program proposal(s) once report is adequate.
- ISBE may schedule on on-site review if it deems the visit necessary.
 - Final report written by ISBE staff or on-site review team. ISBE staff recommends approval or denial to SEPLB.
- SEPLB review IR, program proposals, site visit report (if applicable) and recommend approval or denial to State Board.
- Recognition is valid for 7 years and conforms to state reporting requirements.
 - Institution must go through a process for continued-recognition every 7 years.

Part 25, Section 25.120: Initial Approval of Education Preparation Programs by the State Board of Education

- Shortage and Conceptual Framework requirements removed.
- Assessment requirement simplified.
- Standards required have been clarified to include both state AND national content standards, CAEP standards, SEL standards, and IPTS.
- Program proposals include new requirement that institution demonstrate how candidates gain experience with technology relevant to the profession.

Part 25, Section 25.125: Accreditation of Educator Preparation Providers and Approval of Educator Preparation Programs through CAEP

- Institutions that are recognized in IL and offer at least one preparation program that has been approved by SEPLB for a year or more may choose to seek accreditation of the EPP and all preparation programs it offers through CAEP.
 - Steps institution must take are detailed in this section.
 Must follow reporting listed under "Review of EPPs Beginning December 1, 2018."

Part 25, Section 25.127: Reporting; Review of State Reauthorized Educator Preparation Providers and Individual Programs

- Programs must submit proposed changes 60 days prior to the proposed change taking effect.
 ISBE staff will review changes and make recommendation to SEPLB. SEPLB will make recommendation to State Board to accept, modify, or reject changes.
- EPP change from CAEP accreditation, or vice versa, ISBE must be notified.

PROGRAM APPROAL

Alternative Educator Program Proposal

A program proposal has been created for those institutions that are interested in offering an alternative educator program. Please note that the proposal includes all requirements for an alternative educator program and institutions should then modify it to include the type of alternative program they wish

to propose (i.e. early childhood, elementary, middle grades, secondary, K-12, PK-21).

Middle Grade "Fast Track" Program Proposal

On Friday, October 7, 2016 SEPLB approved the MG Fast Track Proposal. This program proposal may be used by institutions that have a middle grades program proposal already approved by the Illinois State Board of Education and are seeking to offer a Middle Grades program outside the four core areas (Language Arts, Social Science, Science and Math).

For SEPLB approval, the "Fast Track" program proposal must be submitted with the Middle Grades Program Proposal that was originally approved, including any appendices.

Please note for institutions submitting "New" Middle Grades Programs, this Fast Track proposal does not need to be completed in addition to the Middle Grades Proposal. There is an area on the Middle Grades Proposal for institutions to indicate coursework in areas outside the four core areas.

Program Change Notification Form

Per 25.127, institutions must submit program changes 60 days prior to implementation of the change. A new form was created to assist institution in their submission. The form allows institutions to include changes, not limited to:

- Mode of delivery
 - Please note: If the proposed mode of delivery change includes 50% or more courses within an approved

program, a new program proposal is required.

- Adding/Removing courses
- Title/Numbers
- Adding an additional foreign language program.

Program Discontinuation Form

Per 25.115, institution must submit notice of discontinuation of an approved program no later than 30 days prior to taking actions.

Partnership for Educator Preparation (PEP)

In order to advance the work of educator preparation programs statewide, The Illinois State Board of Education (ISBE) is embarking on a significant effort to strengthen data collection, sharing and reporting. The Partnership for Educator Preparation (PEP), a steering committee consisting of a diverse team of stakeholders representing the state, will provide input and guidance in the design and content of ISBE's revised accountability and program improvement system for teacher preparation. The goal of this new system is to ensure that all novice teachers in Illinois are ready to support student learning upon entering the classroom, and that data is used as a tool for continuous improvement to strengthen teacher preparation statewide.
