Background

- Elementary Education: Endorsement awarded for K-9 (through January 31, 2018)
- Beginning February 1, 2018: Grade range changed to 1-6
- September 1, 2019: Deadline for Illinois program completers to be entitled for K-9

Framing and Context

- Requests from field- difficulty assigning properly licensed teachers to kindergarten positions
- Could:
 - allow more flexibility in teacher assignability across grades
 - provide a greater pool of qualified potential applicants
 - increase applications in rural or hard-to-staff schools
 - reduce substitute teachers or other means of temporarily assigning educators to roles due to lack of qualified teachers

Change for Current Educators

- Educators who hold a PEL endorsed for 1-6 Elementary Education
 - Immediate option: Can apply in ELIS for Kindergarten approval
 - Application is planned to be available by **July 1, 2025** (due to changes needed in the ELIS system.)
 - Future Option: Can apply in ELIS for K-6 to receive new grade range. No additional requirements. *
 - Application will be available **summer 2026***

Changes for Preparation Programs

- Candidates in 1-6 Elementary Education Programs
 - Each IHE must at minimum, complete an analysis of its program and notify ISBE that it will be making changes or will not be making changes. This notification is due **December 1, 2025**.
 - If changes are made, the IHE must submit documentation showing aligning to elementary standards by **February 1, 2029**.
 - Candidates may earn the K-6 endorsement after notification of no changes, or after submission showing changes is submitted to ISBE
 - By **July 1, 2029**, all new and existing programs will be valid for K-6 (any changes to programs must be in place by this date)
 - By **July 1, 2030**, all 1-6 entitlement recommendations must be completed by the EPP

Rule

- Changes will be memorialized in applicable Parts of Illinois Administrative Code (rule)
- Public comment period for stakeholder comment

CAEP Elementary Education Standards

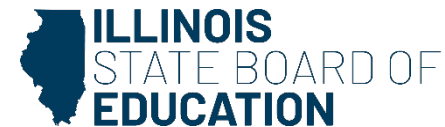
- ISBE will delay elementary education preparation program alignment to the CAEP elementary education standards to February 1, 2029 (rather than September 2025) to ensure reasonable alignment between deadlines for any program redesign needed.

Timeline

July 1, 2026 <i>(anticipated)</i>	<p>Elementary Education (K-6) will be available for application in ELIS. *</p> <p>Kindergarten approval will no longer be available for application*</p>	<p>Educators who hold the 1-6 elementary education endorsement</p> <p>New license seekers who were not prepared through an approved Illinois elementary education program</p> <p>Educators already endorsed in a teaching field who seek to add a subsequent elementary education endorsement</p> <p>Candidates in Illinois approved elementary education programs that have already submitted notification of no changes or have received ISBE approval of program changes</p> <p>*Conversations surrounding this endorsement are ongoing and requirements may change</p>

December 1, 2025	Program analysis and notification of changes/no changes due to ISBE *	Illinois Elementary Education Preparation Programs
February 1, 2029	<p>Elementary Education Program Changes due to ISBE *</p> <p>Programs may begin entitling for K-6 (at their discretion) as soon as program changes are approved *</p>	Illinois Elementary Education Preparation Programs that declared they will make program changes
February 1, 2029	Program alignment to CAEP Elementary Education Standards due to ISBE*	All Illinois Elementary Education Preparation Programs
July 1, 2029	Any candidate who enrolls in an elementary education program on or after this date shall receive the K-6 endorsement. *	All Illinois Elementary Education Preparation Programs
July 1, 2030	All candidates must be entitled for 1-6 endorsements. *	All Illinois Elementary Education Preparation Programs
