BILINGUAL EDUCATION ENDORSEMENT

Effective April 21, 2021, the State Seal of Biliteracy can be used in lieu of the test to earn the Bilingual Education Endorsement. This change allows flexibility for individuals who are fluent in the language for which they seek an endorsement. Full rulemaking on this change and other changes in Illinois Administrative Code Part 1 can be found <u>here</u>. Our team is currently determining the most efficient way to collect recipient names for these seals in ELIS. Once these processes are in place in ELIS, educators may begin utilizing the seals in place of the test. More information will be forthcoming.

GRADE RANGE REMINDERS

As you recall, grade ranges for physical education, health, fine and applied arts, administration, and career and technical education areas were expanded in October 2020. This change is applicable to an initial Professional Educator License and subsequent endorsements. Here are a couple reminders regarding those changes.

- 1. Any programs that are making changes to their requirements (coursework, clinical hours, fieldwork placements, etc.) based on the grade range updates, must be submitted for approval to ISBE staff by June 30, 2023. If no changes are being made, notify your ISBE liaison and you can entitle using the updated grade ranges now. IHEs should not entitle for the expanded PK-12 teaching grade range until they have submitted a program change form to ISBE or confirmed that no program changes will be made.
- 2. For IHEs that have submitted changes or do not plan to change program requirements: If you haven't already, make any grade range updates to candidates in pre-completion for a PEL and/or endorsements that have an expanded grade range. Most commonly, candidates who are in pre-completion for principal or superintendent programs should be entitled for PK- age 21.

Use the <u>grade range cheat sheet</u> as a reminder to the updated grade ranges. Make any updates for your candidates in pre-completion as applicable.

MERGING ELIS ACCOUNTS

We have a new process for merging ELIS accounts that we have implemented to protect the privacy of our educators. Please follow the steps below to assist an educator with merging their ELIS accounts.

- Step 1: Complete the <u>73-71 form</u>. (Be sure to include both Illinois Educator Identification Numbers.)
- Step 2: Upload the 73-71 form and a copy of the Social Security card into both ELIS accounts. Or the educator may email the form to <u>licensureforms@isbe.net</u>.
- Step 3: Please notify your ISBE liaison or email <u>roe@isbe.net</u> stating the accounts need to be merged.
- Step 4: After receiving your notification, the ISBE team will complete the ELIS account merge
 process. ISBE will not be storing Social Security number information after completing the account
 merge process.

CONTENT TEST UPLOADS

Content test reports cannot be uploaded onto ELIS accounts as batch files at this time. The ELIS team is working on a solution. In the meantime, if you have a candidate who has a job pending, notify your liaison and the test can be added manually upon request. Thank you for your patience as the issue gets resolved.
