

The Illinois State Board of Education (ISBE) is excited to announce that Illinois will be participating in the USDA's Local Food for Schools Cooperative Agreement Program (LFS). This new program will provide 7.3 million dollars to ISBE, that is available to School Food Authorities that participate in the National School Lunch and/or School Breakfast Program to purchase local unprocessed and minimally processed food. The funding period for these funds is August 2023 through January 2025.

Fast Facts about LFS

- The funds must be used for foods to be served in the National School Lunch Program (NSLP), School Breakfast Program (SBP), After School Snacks and/or Seamless Summer Option (SSO) meals.
- The foods purchased must be grown, raise, produced and if processed, processed in Illinois or within 400 miles of the school's location.
- The foods must be unprocessed or minimally processed. This includes cutting, chopping and butchering. The items cannot be pre-cooked with no additives.
- Schools should target to purchase from socially disadvantaged farmers/ranchers and/or small businesses. It is not a requirement to purchase from socially disadvantaged or small businesses, it is just a target. Schools should try to gather this information for reporting purposes.
- 100% of the funds must be used to purchase local foods. Allowable expenses do include the cost of the food, storage of the food and delivery of the local foods. The funds cannot be used for other costs such as equipment, gas surcharges, staffing and/or administrative costs.
- The funds awarded must supplement (by increasing or expanding) but not duplicate, existing food purchases.
- Purchases can be made directly from the farmer, rancher or producer or from a processor or from a
 distributor. Just keep in mind that no matter who a school purchases from they will need to know
 information about all of the parties in order to ensure that the local requirement is met and for data
 collection purposes.
 - For example: if a school purchases beef through a distributor. The school will need the name of the distributor and if they are socially disadvantaged or a small business. The school will also need to know the name of the processor of beef and will need to know where they are located (in IL or within 400 miles of the school) and they will need to ask if the processor is socially disadvantaged or a small business. The school will also need to know the name of the ranch and the address, again to ensure that the product meets the local requirements, and they will need to ask if the ranch is socially disadvantaged or a small business. Remember that the socially disadvantaged and small business information is not a requirement, it is just a target and also please note that if any of these parties do not wish to disclose this information you can still purchase from them.
- This is a reimbursement program therefore, schools will purchase allowable items and complete a monthly claim for reimbursement. ISBE will review those claims and reimburse the school for all allowable expenses.
- For food safety requirements please see our food safety resource on the Farm to Child Nutrition Programs website. Requirements may vary from county to county. 89% of schools are receiving less than \$10,000 which allows them to select who they purchase from as long as the price is reasonable.
