**CTE METT PATHWAY PURPOSE:** The Illinois State Board of Education is committed to providing students with a well-rounded and relevant education that includes equitable opportunities to participate in Career and Technical Education (CTE). CTE programs prepare students for both the workforce and the pursuit of postsecondary opportunities by offering students opportunities to develop technical and employability skills while also strengthening core academic skills and abilities. CTE programs are expanding nationwide and including pathways that respond to current and future economic and occupational needs.
