To become a vendor in Illinois, the company will need to comply with the State of Illinois Secretary of State and the Department of Public Health to ensure the business has the appropriate licensing.

Once the company has met the requirements above, they can notify ISBE that they would like to be included on their list of known vendors and may be contacted in their future solicitations for meal services. The company cannot engage in any further “selling” of their services (including consultation, phone calls, presentations at school boards, etc.) directly to Child Nutrition Program participants as there are state and federal procurement regulations that prohibit that.

ISBE also maintains this list of potential known vendors to aide our School Food Authorities (SFA) in their solicitation process. The list is not all inclusive and each SFA has a right to solicit from companies not listed within who can meet their needs while complying with all federal rules and regulations of the Child Nutrition Programs.
