1.1 **Support** best practices and continuous quality improvement, including an emphasis on equity and diversity in order to support student learning while also addressing remote and blended learning.

#### By end of the 2020-21 school year

The Curriculum Evaluation Tool (CET) will be developed, refined based on stakeholder feedback, and made available to all schools/districts. A pilot of 5% of districts will use the ISBE CET.

#### By end of the 2021-22 school year

At least 25% of districts will use the ISBE CET and at least 10% of districts that used the CET will have maintained or improved student performance on state assessments.

### By end of the 2022-23 school year

At least 50% of districts will use the ISBE CET and at least 20% of districts that used the CET will have maintained or improved student performance on state assessments.



# **Goals & Logistical Reminders**



### **Current Data**

- Goal: 25% of district will use the CET ~213 districts
  - As of today we have had 3 ROE's certify they have worked directly with districts using the CET and have completed the certification of use


#### **Moving Forward**

- Survey through IARSS to get a feel of what is in the pipeline
- Removing the 25% restriction- any participating ROE can work with more than the initial 25%
  - Reimbursements will be made on a first come first serve basis
- Scaling communications efforts
  - Weekly message, click dimensions

### **Moving Forward**

- Opening up the reimbursement process directly to districts
  - The ideal situation is still for ROE's to be there to help districts walk through and use the CET- as you all are the experts in the field and can offer the additional supports the district will need once they have completed the tool



### **Goals & Logistical Reminders Recap**



- Not on track to meet our goal of working with ~213 districts.

#### How are you rolling out the tool?

- Helping districts adopting a new curricula. Using tool to evaluate the current curricula and to evaluate new curricula options.
- Getting into buildings has been hit or miss. SpEd cooperatives are supporting districts based on their identified needs. Many are still in survival mode and haven't really explored curriculum evaluation initiatives; maybe curriculum alignment and priority standards. Offering the tool during network meetings
