## Partnership for Educator Preparation Work Concludes with IEPP Launch

The Illinois State Board of Education (ISBE), alongside stakeholder groups statewide, concluded the work of the Partnership for Educator Preparation (PEP) in early December 2020 with the launch of the Illinois Educator Preparation Profile.

The Profile is a new interactive report that provides a holistic view of all approved educator preparation programs within colleges and universities in Illinois and supports continuous improvement in preparation programs to advance toward the goals of diversifying the teacher workforce and better meeting school districts' needs.

The Illinois Educator Preparation Profile gives us an opportunity both to recognize programs that are producing the diverse and learner-ready teachers our students need and to use data as a tool for continuous improvement. Fifty-two Illinois colleges and universities offer more than 700 approved teacher prep programs. Illinois' educator preparation programs prepare teachers in 49 endorsement areas and produce an average of 5,000 teachers every year. The Illinois Educator Preparation Profile contains individual reports for each program, as well as a statewide overview. ISBE will update the Profile annually.

## What's Next? Continuous Improvement of the New System

#### Upcoming Reporting Cycle: February 1 - April 30, 2021

The next reporting cycle for IHEs to report 2020 candidate data in teaching, school support personnel, and administrative programs.

#### IHEs Access 2020 Reports and Reauthorization of Programs: June 2021

Starting this year, reauthorization decisions will be based on the Illinois Educator Preparation Profile (IEPP). The IEPP and the reauthorization process will highlight programs that are producing strong learner-ready teachers and will also help struggling programs seek assistance and improve their effectiveness. Beginning in 2021, reports will have formal regulatory consequences for renewal and continued approval. #### "What's Next?" Continued

#### **Expanding IEPP to Include More Data:**

The 2020 Illinois Educator Preparation Profile, Contribution to State Needs domain only considers the employment and persistence of program completers in Illinois public schools.

ISBE has partnered with the Illinois Department of Employment Security (IDES) so future releases of IEPP will include program completers who work outside the public school system in Illinois but within the education sector (e.g., private schools, community-based organizations, or other education-related fields).

#### **Principal and Administrative Work:**

ISBE recently added a new department to the agency titled District/School Leadership. This new team, in conjunction with ISBE administration, will continue reviewing the Principal metrics and determine next steps for implementation of those metrics into the Annual Program Report system reports.

#### Additional IEPP System Refinement and Enhancements:

ISBE will continue to explore and consider the addition of the following domains and indicators:

Domain: Candidate Selection and Completion

New Indicator: Teaching Promise Domain: Knowledge and Skills for Teaching

New Indicators: Novice Teacher Survey

**Supervisor Survey** 

Domain: Performance as Classroom Teachers

New Indicators: • Impact on K-12 Students

> K-12 Perceptions of Teachers

## North Third User Research Results .....

ISBE partnered with North Third, a consulting team that helps education agencies use data, to conduct user research to inform the Illinois Educator Preparation Profile. The goal was to understand what information IEPP users need from public reporting and motivations for using that data. The findings were used to inform the structure and design of the public reports, their content, and communications strategies for their publication.

## KEY FINDINGS

- Users generally reported that they would use the site to:
- Find a program
  - Learn information about a program
  - See the IEPP score
  - See how the program compares to the state and see statewide data


PEP 2020 Wrap-Up Report

#### Day-to-day users plan to:

- District hiring managers reported they will use the profiles to focus their recruitment efforts.
- Prospective teaching program candidates reported that they could use the profiles as a centralized point for exploring program options, particularly by endorsement area or location.
- IHE staff reported that they would consult their own program's information to understand how it is represented to the public, and to understand how they compare to the state and others.
- School building staff might benefit from this tool: 76% of students shared they get information about preparation programs from their high school principals, teachers, or other staff.
