
Goals

 - -Ninety percent or more of third-grade students are reading at or above grade level.
 - -Ninety percent or more of fifth-grade students meet or exceed expectation in mathematics.
 - -Ninety percent or more of ninth-grade students are on track to graduate with their cohort.
 - -Ninety percent or more of students graduate from high school ready for college and career.
 - -All students are supported by highly prepared and effective teachers and school leaders.
 - -Every school offers a safe and healthy learning environment for all students.

Parent and Family Engagement ESSA Guidelines

ESSA (Every Student Succeeds Act) Policy (ESSA Section 1116):

- Each district receiving Title I funds must have a written policy that is jointly created with and distributed to parents and family members of participating students. The policy requires the following:
- Establish expectations and objectives for meaningful parent and family involvement to improve student academic achievement and school performance incorporated into the Title I District Plan.
- Coordinate and integrate parent and family engagement strategies with other relevant federal, state and local laws and programs.
- Conduct an annual meeting and evaluate the effectiveness of the policy in improving quality of Title I schools, including identifying barriers to greater participation by families and the needs of parents and family members to assist with the learning of their children; and,
- Conduct meaningful consultation with parents of participating children, which may include establishing an advisory board to develop, revise and review the engagement policy.


 An outline of how parents, school staff, and students will build and develop a partnership to help students succeed.

Parent's Right To Know

 School districts receiving Title I funds are required to notify families of Title students of their rights to request and receive information regarding the professional qualifications of students' classroom teachers.

Top 5 Reasons Why Districts Should Participate in Foundational Services Family Engagement Training

 Well-designed family engagement efforts can maximize school resources.

- 4. Family engagement requirements are embedded throughout Title I, Title III, Title IV, and IDEA grants.
- Title I provides the guidance and funding for family engagement, however family engagement is embedded in a number of statutes and appropriations in ESEA.

- 2. A lack of systemic opportunities for district and school staff to build their capacity to effectively engage families in partnerships that support student achievement and healthy development, and the improvement of schools.
- 1. 76% of respondents to a statewide family engagement survey² indicated that they would like access to trainings and coaching on family engagement practices and resources.



Title I: Allowable Expenses Parent and Family Engagement

Allowable Expenses

Parent and family engagement coordinator salary

Parent University and parent training

Guest speakers and supplies for family night and family/parent event activities (college night, FAFSA assistance)

Light refreshments to support meetings and attendees

Printing, binding, publishing services for distribution of materials to parents

Activities and supplies to support parent meetings

NOTE: If Targeted Assistance: Only targeted/identified students may be served/benefit from funding

Allowable Expenses

Professional development training for parent and family engagement coordinator

Professional development training to help teachers and staff engage families

Family engagement guest speakers, workshops, and conferences

Family engagement books and materials and training assistance



Title III-A: Allowable Expenses:

Use of Title I Funds for ELs – Parent and Family Engagement

Purpose

Attendance to the state wide EL Parent Summit

Involving parents in the activities of the school served under Title I.

- Bilingual Parent Advisory Council
- Professional development for parents to learn about Title I
- Professional development for parents to support their Title I student(s)

Literacy programs that focus on the development of:

- English literacy
- English language
- Parent-child reading activities for EL students



Title IV-A: Allowable Expenses: Safe and Healthy Students

Allowable Expenditures

Anti-bullying efforts, drug and violence prevention services, and dropout prevention services/workshops/seminars

Re-entry programs and transition services for justice-involved youth/workshops/seminars

Nutritional education and school-based health and mental health and trauma informed services/workshops/seminars Ex: A community movie viewing and a panel discussion to follow the movie.

Child sexual abuse awareness and prevention services/workshops/seminars

Reducing exclusionary discipline practices and promoting supportive school discipline (Restorative Justice Practices)

Suicide prevention, relationship-building, and School Resource Officer services/workshops/seminars
