# Preparation and Evaluation

A subtle change has been made to the ISBE webpage to separate higher education information from information educators utilize when seeking licensure. On the ISBE homepage, we encourage all institutions of higher education to select "Preparation and Evaluation". Please advise candidates to select "Educator Licensure" for all information regarding licensure, requirements, endorsements and approvals. #### New Website

ISBE is pleased to update institutions of higher education that our new website is still on track to debut this summer. The vision for the website includes new licensure and preparation pages that offer users an experience where essential information is easy to find and navigation is simple.

### WEBINARS

#### Peer Review Training

Peer review training has been conducted for superintendent and early childhood education program proposals. There was great interest in the peer review process as ISBE formed three superintendent teams and six early childhood education teams. The teams are currently reviewing and providing feedback for proposals submitted in April. Proposals submitted during the month of April will be reviewed during the month of May and feedback will be provided by the first week of June.

#### Please Note:

When an institution receives the completed review matrix from a peer review team, we recommend that changes to the proposal be made in a different color. Institutions are not recommended to submit the original proposal with an addendum outlining the changes. The State Educator Preparation and Licensure Board prefers changes be embedded within the proposal.

If an institution requests to undergo a second review, the proposal is assigned to the same team to ensure consistency in feedback.

#### Middle Grades

ISBE offered a peer review training for new members of the middle grades peer review teams. The training was completed May 5, 2016, and included a general overview of Administrative Code rules and

requirements in Part 21 and Part 25.99. The middle grades peer review webinar also included an overview of the new proposal format design components, as well as the review matrix our reviewers use to facilitate the proposal evaluation.

The new peer review teams will begin reviewing proposals in May.

## HIGHLY QUALIFIED TEACHERS

**HQ** Status

With the passage of the Every Student Succeeds Act (ESSA), some provisions are being phased—in or phased—out with full implementation in 2017-2018. One provision that is no longer required for the 2016-17 school year is the Highly Qualified requirements for teachers and paraprofessionals as outlined in section 1119 of the Elementary and Secondary Education Act (ESEA).

Effective July 1, 2016, teachers and paraprofessionals must meet State and local licensure requirements.

The information provided on the highly qualified webpage will be archived July 1, 2016.

## LICENSURE OFFICERS

LO Webinar2.0

## PROPOSED RULES AND AMENDMENTS

Rules undergoing amendments are found <a href="here">here</a>. As Rules are proposed and amended, this webpage provides a summary of the Rule, a medium for public comment, and status updates as Rules are filed and adopted.

The following Administrative Rules are open for public comment until May 16, 2016:

- Part 1(Public School Evaluation, Recognition and Supervision)
- Part 20 (Standards for Endorsements in Elementary Education)

- Part 25 (Educator Licensure)
- Part 26 (Standards for Endorsements in Early Childhood Education and in Elementary Education)

The following Administrative Rules are open for public comment until June 13, 2016:

- Part 30 (Programs for the Preparation of Principals in Illinois)
- Part 33 (Programs for the Preparation of Superintendents in Illinois)

## PROFESSIONAL DEVELOPMENT

Effective January 1, 2015, Illinois approved professional development providers, including higher education institutions, may grant professional development hours (PDHs, aka CPDUs) for any activity that complies with state statutory PD requirements. Conversely, approved providers are not obligated to grant PDHs simply because an educator requests them. Approved providers are responsible for ensuring ISBE that the content of the activities for which they grant PDHs meets state statutory PD requirements (see 23 IAC §25.855).

One way to determine if an activity meets the statutory PD requirements is to complete an Approved Professional Development Provider Activity Summary form (ISBE 73-58) prior to issuing an Evidence of Completion form (ISBE 77-21B). The Approved Professional Development Provider Activity Summary form also captures all the information providers are required to document for auditing purposes. Providers must collect an

Evaluation form (ISBE 77-21A) for all activities for which an Evidence of Completion form is issued. For individualized and/or online activities or other activities that are not conducive to keeping an attendance roster, the provider must be able to document the beginning and ending dates and times the educator engaged in professional development work. Some providers use signed affidavits for this purpose.

PD credit is granted at the rate of one (1) PDH per one (1) hour of engagement in professional development activities. ISBE published guidelines and recommendations can be found here. The statute of limitations for educators to count professional development activities toward license renewal requirements is fiveyears. All professional development activities applied toward license renewal must be completed between July 1 of the first year of the cycle and June 30 of the final year of the cycle. There are no limitations on providers related to issuing professional development credit retroactively.

The decision to grant PDH to cooperating teachers lies with the higher education institution.

#### Form 73-59

The Approved Annual Provider Report form (ISBE 73-59) is only required if an IHE grants credit on behalf of a third party. For example, if a local community organization puts on a workshop and asks the college and university to issue the Evidence of Completion form so teachers who attend can receive PD credit, IHEs are not required to submit the report for

entities/individuals with whom they contract directly.

## THE FUTURE OF ILLINOIS MIDDLE GRADES

ISBE will release an informational guide for educators, stakeholders and IHEs that provides depth and clarity as Illinois transitions to the "new" middle grades programs. The guide will capture the reasons behind the transition, the options educators have to receive endorsements in middle grades, and common scenarios licensure officers can utilize when advising candidates. The information guide is currently undergoing approval and will debut soon.

### **SAT**

The College Board will release the redesigned SAT to old SAT concordance tables this month. ISBE will use these concordance tables to recommend a cut score for the redesigned SAT. This summer SEPLB will establish a new cut score for candidates that complete the redesigned SAT March 2016 or after.

Candidates that have completed the SAT prior to March 2016 will need to meet the composite score of 1030 (mathematics + critical reading) with a minimum writing score of 450.
