

2014-15 Academic Year

The window to submit the APR opened October 1<sup>st</sup> and will close November 30<sup>th</sup>. The annual program report is submitted through IWAS by your institutions IWAS administrator. Once submitted to ISBE, no changes can be made.

As the deadline fast approaches we want to ensure all IHEs are ready to submit their report by November 30<sup>th</sup>. ## edTPA

### ENTITLEMENT

ISBE has uploaded approximately 2,500 edTPA scores into educator ELIS accounts. There were 500 scores that could not be uploaded because educators either have not created an ELIS account yet or their name/SSN reported to edTPA did not match their account in ELIS. We will attempt to upload these scores again in December, and will continue to attempt to upload unmatched scores each time a new batch is received from edTPA.

#### HANDBOOK

ISBE is aware of the concern regarding the videoing element of the edTPA. In an effort assist school partners and parents, we have created an edTPA handbook to address this and other issues. This handbook outlines the notable purpose of edTPA and encourages best practice in the confidentiality of all K-12 students. The handbook will be made available by early November.

#### PORTFOLIOS

As candidates are placed in Illinois schools for their clinical experience, ISBE recommends that educators submit edTPAs that align with their student teaching. For example: If an educator is pursuing an elementary education (K-9) license and is doing their student teaching in a middle school science classroom, the educator should prepare a middle grades portfolio. #### REMINDERS

Illinois has established a ramp up policy for incrementally increasing the edTPA passing scores over the next 3 years. ISBE recommends you share this with your candidates so they know what to expect. The timeline for implementation is listed below:

## LBS I COURSEWORK

ISBE has determined that it is appropriate to accept LBSI coursework that is specific to the grade range of the educator's underlying endorsement. *For*  Example: If an educator is endorsed in early childhood education (B-3) and applies for the LBS1 endorsement, we can honor LBS1 characteristics, methods and assessment course work that is specific to "young children", "ages 3-6", etc. Coursework does not

### EdTPA MYTHS and FACTS

**Myth:** Determining whether a candidate is prepared for the classroom cannot be measured by assessing a 20-minute recording of their classroom practice that can be edited and/or chosen as a representation of their practice as a whole. Fact: Much like the National Board portfolio and the Measures of Effective Teaching (MET) studies, candidates are not judged solely on a 20-minute video. The video clips illustrate how candidates enact various aspects of effective teaching are inextricably linked with multiple sources of evidence including real artifacts of teaching including lesson plans, student work samples, and instructional materials. Candidates also provide commentaries justifying their lesson plans based on their students' strengths and needs, analyzing student work, explaining feedback to students, and proposing next steps for teaching and learning. Developing a reliable understanding of whether a candidate is prepared to be the teacher of record in their own classroom requires the use of multiple measures of skills, practices and performance. There is no single approach that can measure teacher competence; given how complex and varied the knowledge base is for measuring effective teaching. edTPA is a capstone, summative assessment that contributes to a multiple-measures system for licensure.

# **Ouestions and Answers**

Q: Is there a test for the TeacherLeader endorsement?A: No. Currently there is no required test.

Q: How long are ACT scores valid? A: ACT Scores are valid indefinitely, as are the TAP and SAT. The content test, APT and edTPA scores are valid for 10 years.

Q: What is the status of revising special education programs?
A: The CEEDAR state leadership team has been meeting monthly to develop suggestions for special education standards. This work will continue into the spring of 2016.

Q: Now that the edTPA is consequential, are institutions required to use the edTPA as a program assessment?A: *IHEs may use the edTPA as a program assessment.* 

Q: Would we need to make any changes to our existing programs if we add the option of a semester abroad student teaching experience?
A: Conducting student teaching outside Illinois is an institutional decision. However, student teaching needs to be completed under a teacher who holds a current Illinois PEL. No change notification form is needed. The institution needs to ensure all requirements of 23 Illinois Administrative Code Section 25.620 for student teaching are met.

#### have to span the K-12 grade range.

The K-12 grade range requirement is not listed in Rules for LBS1 endorsements on PELs; rather, it stems historically from issuance of the old "special" certificates endorsed for special education. We plan to add a new section to rules to specify grade ranges for endorsements and they type of course work needed for each one.

Q: If candidates complete a new Middle Grades program in a content area before the content area test is ready, can they be entitled without passing the middle grades content test? A: The current Elementary/Middle grades (110) content test will be available through 1/31/2018. Once the new middle grades tests are developed, an educator my elect to take either the new middle grades content test or the current (110) content test through 1/31/2018.
