GENERAL INFORMATION

- I. Each day of hearing will be live-streamed via the Illinois State Board of Education's website at <u>www.isbe.net/publicinquiry</u>. Closed-captioning will be provided via separate link on the same webpage.
- II. We welcome members of the public to attend the public inquiry hearings. However, we will not be taking questions for the audience and there will be no public comment period for public participation.
- III. All three days of the hearing will take place in the auditorium of Chicago-Kent College of Law located at 565 West Adams Street, at the southeast corner of Adams and Jefferson Streets in downtown Chicago. Chicago-Kent is located one block south of Union Station and three blocks south of the Ogilvie Transportation Center. The law school is located within walking distance of the Clinton station on the Green and Blue lines and the Quincy station on the Brown, Orange, Pink and Purple lines. Parking is available at various pay lots around the college and at metered spots on the street.
