- District Review: July through August
- Data Finalization: August and September
- Publish Report: October

- August 15-16: Final Deadlines

 - Assessment Corrections (8/16)
- September 7: Superintendent Sign-off Due
- October 1: Summative Designation Release / Superintendent Preview
- **October 15: Principal Preview (tentative)**
- October 30: Report Card Release
