

Description: SAT Suite of Assessments: Score Data Workshops

The College Board, in partnership with the Illinois State Board of Education (ISBE), is excited to announce upcoming interactive workshops to be held in June 2019. These 2.5 hour workshops will enable educators to effectively understand the data from the PSAT 8/9, PSAT 10, and SAT School Day spring administration. The workshops will also engage participants in how to access the Online Score Reporting Portal and how to use the features of the portal to effectively utilize the data and reports. Workshop information will cover:

- Methods for how to measure student progress towards college and career readiness
- Tools and reports that are available to understand and interpret scores
- Strategies to connect reported information with classroom instruction, to monitor student progress, and to use data to review, evaluate, and adjust curriculum

In addition, a review of the coaching tools available through the Official SAT Practice on Khan Academy will be provided.

Lastly, the steps for accessing the AP Potential tool will be reviewed. Best practices for using the data from AP Potential will be shared.
