Dear English Language Program Director,

In previous weeks, ISBE has sent a series of notes regarding ACCESS 2.0 and instruments used for reclassification. In response, a number of superintendents and English Language Program Directors shared follow-up questions.

What follows is a summary that includes the following information: screening instruments used and cut scores for when a student may require EL services, requirements for part-time TBE enrollment, and the ACCESS 2.0 required reclassification score for the 2017-2018 school year.

## **Screening for initial EL services:**
