### TEACHER DATA WAREHOUSE AGREEMENT

#### ILLINOIS STATE BOARD OF EDUCATION

- 1. The Illinois State Board of Education (ISBE) agrees to share data with the University of Illinois (U of I) and the Illinois Board of Higher Education (IBHE) solely for the limited purpose and extent regarding the Teacher Data Warehouse (TDW) as set forth in the attached SPECIFICATIONS.
- 2. This Agreement shall become effective upon its full execution for a period of one year, and may thereafter be re-executed on an annual basis, as needed, without any further written agreement required among the parties.
- 3. All records and other information maintained by ISBE regarding any person are confidential and shall be protected from unauthorized use and/or disclosure under this Agreement. Any dissemination or use of the teacher data for other than the primary purpose of this Agreement without the express written authority of ISBE's Division Administrator for Data Analysis and Progress Reporting is specifically prohibited. Data released under this Agreement are to be used only for the specific purposes as described in the attached specification sheet. U of I and IBHE further agree to comply with the attached laws, materials, regulations and all other State and Federal requirements with respect to the protection of privacy, security, and dissemination of this teacher data.
  - a. Access to and uses of the data files containing individual student data are restricted to submitting institutions, IBHE and ISBE. An institution will only receive data on students enrolled or that have been enrolled at their institution.
  - b. The institutional data in the TDW belong to the submitting institutions and the ISBE data in the TDW belong to ISBE. Individually identifiable data may only be released with the prior consent of the owner or pursuant to the exceptions covered in this Agreement. Aggregation of the data for internal research and internal/external required reporting is appropriate for each institution/agency.
  - c. The confidentiality restrictions identified in the Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. 1232g, 34 CFR 99.30 et seq.) apply to the use and release of the teacher data exchange files. As a part of FERPA compliance, data received by each institution are to be used for internal research and/or external reporting requirements, including but not be limited to the Title II legislation (Federal Higher Education Amendment, 1998) and the Illinois Supply and Demand Report (Public Act 91-102). External reports may not identify individual student data (See 34 CFR 99.31(a)(6) and 99.35(b).)
  - d. The U of I will maintain a list of all U of I and IBHE officials and employees with authority to request, receive, or obtain information from the TDW. The U of I will also maintain a list of all officials and employees from submitting institutions with authority to request, receive, or obtain information from the TDW. Each submitting institution that has access to the TDW must have a signed security agreement on file at the U of I, with a key holder named for each

- 11. U of I, IBHE, and ISBE are empowered under Article 7, Section 10(a) of the 1970 Constitution of the State of Illinois and the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1, et seq.) to contract with each other in any manner not prohibited by law.

#### TEACHER DATA WAREHOUSE AGREEMENT SPECIFICATIONS

## A. REASON FOR MAKING REQUEST:

Such data are being requested by the University of Illinois at (U of I) pursuant to a Higher Education Cooperation Act (HECA) long-term grant provided by the Illinois Board of Higher Education (IBHE) to the U of I and other designated grant recipients. Data related to teacher education in the State of Illinois will be stored in the Teacher Data Warehouse (TDW) established and maintained at U of I (Champaign-Urbana) pursuant to the above-referenced HECA grant. The organization of these data by the TDW will allow tracking of students from Illinois colleges and university teacher preparation programs and include their performance on the teacher certification exams, certification and endorsement information, their demographic information, and their public educational employment status within the state.

The data in the TDW are collected by the Illinois State Board of Education (ISBE) and educational institutions offering teacher preparation programs (e.g., Chicago State University) and shared with the TDW. The TDW was established with the understanding that the institutions and ISBE would submit data on an annual basis.

#### C. HOW DATA WILL BE UTILIZED:

Data from ISBE will be merged with data from the institutions for reports, maps, and data downloads to the institutions. These same reports, maps, and data downloads will be available to ISBE for internal and/or external reporting.

# CONFIDENTIALITY REQUIREMENTS

AN ACT to make confidentiality requirement governing State agencies applicable to data centers and electronic data processing contractors which store or process confidential information from State agencies.

P.A. 84-347, approved September 14, 1985, eff. January 1, 1986.

585/0.01 Short Title

Section 0.01. "Short Title. This Act may be cited as the Data Processing Confidentiality Act.

585.1. Notice

Section 1. Whenever any State agency governed by confidentiality requirements as to information in its possession gives, contracts out, or otherwise transmits such information in a form suitable for electronic data processing to any contractor, electronic data processing center, or other user outside such agency, for any purpose whatsoever, such agency shall notify the receiver of such data in writing of the agency's confidentiality requirements, including any penalties provided for their violation.

### 585/2. Duty of recipient

Section 2. It shall thercupon become the duty of the individual or entity who receives such data for electronic processing or storage to keep or use the same pursuant to the confidentiality requirements of the transmitting agency, and any receiver who violates them shall be subject to the same penalty that any officer or employee of such agency would incur for their "violation."

#### I. SPECIFICATIONS

# A. REASON FOR MAKING REQUEST:

While the preliminary TSR file may not be final, it contains the most current data related to the school location where graduates are working which is important for conducting the annual survey.
