

### **NCLB** Purpose

- 1) Increase student academic achievement through strategies such as improving teacher and principal quality and increasing the number of highly qualified teachers in the classroom and highly qualified principals and assistant principals in schools;
- 2) Hold local educational agencies and schools accountable for improvements in student academic achievement.

### **ESSA Purpose**

- 1) Increase student achievement
- Improve teacher, principal, and other leader quality and effectiveness
- 3) Increase the number of teachers, principals, and other school leaders who are effective in improving student academic achievement
- Provide low-income and minority students greater access to effective teachers, principals and other school leaders

# District Title IIA Application Requirements

- Description of how the district will use data and ongoing consultation to continually update and improve activities.
- Assurance the district will comply with private school participation requirement.
- Assurance that the district will coordinate professional development activities with professional development activities through other Federal, State, and local programs.



# District Title IIA Application Requirements

- Description of how the activities align with challenging State academic standards.
- Description of the district's system of professional growth and improvement.
- Description of how the district will prioritize funds to schools implementing comprehensive and targeted support and improvement.



### **Consultation Process**

During the development process of the application, a district shall....

### A. Meaningfully consult with:

- > teachers,
- >principals,
- >other school leaders,
- ➤ Paraprofessionals,
- parent community partners...



### **Consultation Process**

- B. Seek advice from the individuals and organizations regarding how best to improve the districts' activities.
- C. Coordinate the district's activities with other related strategies, programs and activities being conducted in the community.

NOTE: Consultation shall not interfere with the timely submission of the application.



# **Nonpublic School Consultation**

 Make sure that you consult with your nonpublic schools regarding participation in Title IIA.

 Nonpublic should sign the documents regardless, indicating if they will participate or not.



- A. Develop or improve rigorous, transparent, and fair evaluation and support systems for teachers, principals, or other school leaders.
- B. Develop and implement initiatives to assist in recruiting, hiring and retaining effective teachers, particularly, in low-income schools with high percentages of ineffective teachers.



C. Recruit qualified individuals from other fields to become teachers, principals or other school leaders.

D. Reduce class size to a level that is evidenced based.



- E. Provide high quality personalized professional development that is evidence based.
- F. Develop programs and activities that increase the ability of teachers to effectively teach children with disabilities and English language learners.
- G. Provide programs and activities to increase instruction in the early grades.



- H. Provide training and capacity building in selecting assessments and data to improve student achievement.
- I. Districts that receive Title II professional development funds must use the money to address the learning needs of all students, including children with disabilities, English learners and gifted and talented students.



   ESSA eliminated the accountability section; however, districts should continue to make progress towards all students meeting the challenging State academic standards





# What happens to the definition of "highly-qualified teacher" (HQT)?

With the new ESSA changes, HQT requirements were eliminated.





# What requirements do professional development programs have to meet?

Under ESSA, professional development programs and activities must be "evidence based," as opposed to the more demanding "scientifically-based" requirement under NCLB. This means these programs have demonstrated a record of success and there is reliable, trustworthy, and valid evidence to suggest the program is effective.





Title II funding for professional development is the only funding some states receive to support educators. Does ESSA allow these funds to be used on other activities?

Yes. Historically, states and districts have been able to transfer up to 50 percent of their Title II funds to Title I. This transferability option was expanded under ESSA to allow all—100 percent—of their Title II funds to be moved to Title I and /or Title IV. However, while funds can be transferred into Title I, money cannot be moved out of Title I into another Title.





# How does ESSA ensure that all educators are properly credentialed and students have access to high-quality instruction?

ESSA maintains the requirement that teachers and paraprofessionals meet state certification and licensure requirements. "Equitable distribution" of educators also remains in the new law, requiring states to ensure "ineffective" (formerly known as "unqualified" under NCLB) educators are being identified and give professional development opportunities.
