First Time You Log In – Change Your Password

You **MUST** change your temporary password. Keep your new password secure, because if you forget it, your account will have to be reset and a new temporary password will have to be assigned.

The first time you log into your Assessment Network account, you will need to activate it.

To do this you **MUST**:

- Enter the First and Last Name of the person responsible for ALL ISAT or IAA activities.
- Enter a VALID e-mail address. All communications regarding the ISAT or IAA test administration will be sent to this individual.

Purpose of this Module

- Understand relationship between district enrollments and pre-id files in the Illinois State Board of Education's Student Information System (SIS) and Pearson's Assessment Network.
- Understand how these student enrollment numbers affect IAA and ISAT testing material orders.

Module I – Enrollment Information

IMPORTANT DATES

- The ISBE deadline to upload initial 2013-14 enrollments in SIS was **Thursday, October 17, 2013.**
- The ISBE deadline for updating the Pre-ID file in SIS for the 2014 ISAT and IAA assessments is **January 3, 2014.**

Module I – Enrollment Information

- **Home School Districts** are responsible for entering and uploading their district's 2013-14 school year ENROLLMENTS and PRE-ID information to ISBE through via IWAS/SIS.

NOTE: Districts should continue to enroll and exit students in SIS throughout the school year as students enter and leave the district even after the enrollment and pre-id deadlines.

- **Serving School Districts** who are not the home district should confirm within SIS and/or communicate with their student's home district to ensure their enrollment information and testing information has been uploaded correctly.

Module I – Enrollment Information

Enrollment File and Pre-ID file Information

- Information that is uploaded by the Home District for student enrollments includes Home School and Serving School RCDTS codes for the October enrollment file and Home, Serving and Testing RCDTS codes for the January Pre-ID file.
- As students are enrolled, information is automatically populated in the Pre-ID file.
- Districts must make any necessary changes in the Pre-ID file prior to the January deadline to ensure accurate testing information is provided to Pearson.

January 3, 2014 Pre-ID File

- Final numbers for all IAA materials and for ISAT regular testing materials will be derived from the **January 3, 2014** Pre-ID file. Home and Testing School codes need to be accurate by that deadline.
- ISAT special-format materials (Braille, Reader Scripts, Large Print, etc.) **MUST** be ordered from Pearson's Assessment Network during the November 1-December 18, 2013 window.
- Specific information regarding the ordering of special format materials will be covered in **Module II – Updating Profiles and Ordering ISAT Special-Format Materials.**
