Pursuant to the requirement of the Private Business and Vocational Schools Act, 105 ILCS 425/14.2, the following list of Private Business and Vocational School names, addresses, visitation dates and complaints for the period, January 1, 2011 through December 31, 2011 are submitted for review.

Please note, Public Act 097-0650, the Private Business and Vocational Schools Act of 2012 was signed into law. As a result of the Public Act 097-0650, the Illinois State Board of Education (ISBE) will no longer maintain authority for approving, regulating and monitoring private business and vocational schools in the State of Illinois. Under the provisions of the Act, the responsibility for oversight of the private business and vocational schools will rest with the Illinois Board of Higher Education (IBHE) effective February 1, 2012.
