## **2008 Physical Education Exemption Report Summary**

The Physical Education Exemption Report was compiled from the electronic submission of IWAS surveys completed by Illinois public school districts. This data collection represents responses from the 2007-2008 school year. The report format was designed to gather a brief description of the public school district policies regarding the allowable individual exemptions, the number of students exempted from the required physical education program in each district, and the grade level of the students granted exemptions by each school district.

**PLEASE NOTE:** In order to simplify the narrative of this report, we have determined it would be best to discuss the individual exemptions for high school students separately. The high school students that have been granted the exemption for special education resource needs will be addressed in the narrative discussing the appropriate policy for grades three through twelve.

### **P.E. Exemptions for High School Students**

Specifically, the survey asked each district to report the number of students in grades eleven and twelve who were granted exemptions from physical education for any of the following reasons allowed in 105 ILCS 5/27-6 of the *School Code of Illinois*:

- *Ongoing participation in an interscholastic athletic program;*
- *Enrollment in academic classes required for admission to an institution of higher learning, provided that failure to take such classes would result in the pupil being denied admission to the institution of their choice;*
- *Enrollment in academic classes required for graduation, provided that failure to take such classes would result in the student being unable to graduate.*

Other high school students that were considered for individual physical education exemptions included students in grades nine through twelve who were granted exemptions for the following reasons:

- *Enrollment in an ongoing marching band program for credit;*
- *Enrollment in a Reserve Officer's Training Corps (ROTC) program sponsored by the district.*

Of the 483 school districts operating high school programs (grades 9-12) in Illinois, 387 (80%) responded to the survey as requested. The 387 responding school districts serve 404,332 (64%) of the 631,127 students enrolled in Illinois public high schools. When asked on the survey if the district offers exemptions to the physical education mandate as permitted in Section 105 ILCS 5/27-6 of the *School Code of Illinois*, 322 (83%) of the responding school districts responded in the affirmative. Sixty-five of the school districts (17%) stated they do not offer any of the allowable individual physical education exemptions for high school students. Based on the information provided by the survey, a total of 33,331 individual physical education exemptions were granted during the 2007-2008 school year by 387 districts. This number represents slightly

more than five percent of the total number of high school students enrolled in the state of Illinois as per the Fall Housing Report of 2007.

Following is a specific breakdown of the exemptions granted by public school districts in each of the five exemption categories for high school students:

1. Interscholastic Athletics (grades 11-12): A total of 12,774 interscholastic athletic exemptions were granted to eleventh and twelfth grade students by 230 (59%) districts that responded to this particular exemption.
2. College Admission Coursework (grades 11-12): A total of 140 (36%) of the school districts granted a total of 5,709 college admission coursework exemptions to eleventh and twelfth grade students for the purpose of enrolling in academic classes required for admission to an institution of higher learning. Failure to take such classes would have resulted in the students being denied admission to the institution of their choice.
3. Classes Required for Graduation (grades 11-12): A total of 3,324 individual exemptions were granted to eleventh and twelfth grade students for the purpose of enrolling in classes that were needed in order for the student to graduate. These exemptions were granted by 158 (41%) of the 387 school districts responding.
4. Marching Band for Credit (grades 9-12): A total of 8,134 exemptions were granted to students in grades nine through twelve for participation in marching band. Of the 387 total school districts responding, 167 (43%) granted exemptions for marching band.
5. Reserve Officer's Training Corps (ROTC) (grades 9-12): Of those school districts responding to the survey, a total of 17 (4%) offered a ROTC program. A total of 3,390 students in grades nine through twelve were granted individual exemptions for participation in ROTC.

The following table illustrates the total number of high school exemptions (excluding the special education services exemption) granted by the 387 high school districts participating in this survey.

## **P.E. Exemptions for Special Education Support Services**

In addition to the individual exemptions for high school students, the law now allows students in grades 3-12 to be exempt from physical education for utilization of this time to receive Special Education Support Services if the pupil's parent or guardian agrees that the pupil must utilize the time set aside for physical education to receive special education services. If there is no agreement, the individualized education program team for the pupil determines that the pupil must utilize the time set aside for physical education to receive special education support and services.

Following is the breakdown of the number of exemptions granted for the utilization of this time to receive Special Education Support Services:

A total of 348 students in grades 3-12 were granted exemptions for time to receive Special Education Services. These exemptions were granted by 22 school districts in the state. This is a newer allowable exemption that was added more recently (2007), and that might explain the low number of responses received for this exemption.

## **Sample Policies**

Although the State Board of Education has provided school districts with specific language of 105 ILCS 5/27-6 regarding the allowable individual physical education exemptions, there still seems to be some confusion about these exemptions.

An examination of a sample of local school board policies received as a result of this survey indicates districts are granting physical education exemptions that are not within the parameters of 105 ILCS 5/27-6. The Illinois State Board of Education and the General Assembly might want to consider adding the following individual exemptions for these areas that were frequently indicated as potential areas for consideration:

- Granting waivers to allow for flexible scheduling of elective classes;
- Granting waivers for participation in show choir, in addition to marching band;
- Granting waivers for students enrolled in work co-op program or the area vocational program if class schedule does not allow them the opportunity to obtain adequate credits for high school graduation;
- Granting waivers to individual students so they can take and receive up to a maximum of 2 units of credit for successful completion of community college coursework. These waivers are granted to seniors who are in "good standing" and the course they enroll in is not available at the high school they are attending;
- Granting waivers to students if a course is needed to meet career entry requirements.
