HB 163	PA 99-84	Flowers/Delgado	Prohibits ISBE from having separate performance standards for students based on race or ethnicity. Effective January 1, 2016.
HB 165	PA 99-410	Flowers/Delgado	Provides that students may voluntarily engage in individually initiated, non-disruptive prayer at any time during the school day including prayer groups, BIBLE (Basic Instruction Before Leaving Earth) clubs, or "meet at the flagpole prayer" days. Effective immediately.
HB 317	PA 99-1	Madigan/Steans	Makes changes and additions to FY 15 appropriations to the State Board of Education and other agencies. Effective immediately.
HB 318	PA 99-2	Madigan/Steans	Among other changes directs the State Board how to spend appropriations included in HB 317. Effective immediately.
HB 806	PA 99-189	Golar/Delgado	Amends the School Code to allow students in Grades 7 or 8 to enroll in a high school course as long as the teacher holds a PEL endorsed for the grade level and content area of the course. Currently these students may only take the course if it is taught by a teacher who teaches in a high school of the school district where the student would attend high school. Effective immediately.
HB 1360	PA 99-325	Gabel/Biss	Requires charter schools to comply with all (instead of applicable) health and safety requirements applicable to public schools. Effective immediately.
HB 1790	PA 99-35	Caveletto/McCarter	Amends the School Code to exempt individuals that were issued the career and technical educator (CTE) endorsement or the provisional career and technical educator (PCTE) endorsement on an Educator License with Stipulations (ELS) before January 1, 2015 from taking a test of basic skills upon renewal. Effective January 1, 2016.
HB 2657	PA 99-58	Winger/Bertino- Tarrant	Amends multiple sections of Article 21B of the School Code to make changes concerning teacher preparation, out-of-state educator and administrator reciprocity, license fees and educator misconduct. Effective July 1, 2015.
HB 2683	PA 99-193	W Davis/Delgado	Amends multiple articles of the School Code that reference the current state accountability system, including provisions requiring ISBE to place districts on academic status based on Annual Yearly Progress (AYP). Pursuant to the terms of Illinois's waiver from provisions of the No Child Left Behind law, these sections would be replaced with new accountability provisions that will include a calculation of achievement, growth and outcomes, along with a calculation of gaps in achievement, growth and outcomes for our subgroups. The new accountability system will allow ISBE to target assistance to districts

			depending on achievement, growth and outcomes. The legislation also creates a Balanced Accountability Measure which will take into account various measures of district performance/practice in the district's overall accountability score. This legislation will apply to state authorized charters, charters within districts, and CPS. This means we will no longer solely be focusing on test scores when it comes to district accountability. Student performance and the districts' ability to close achievement gaps between sub groups will still be a factor in determining the district's accountability measure. The second component we will now be looking at includes 3 parts: compliance, evidence-based practices and contextual improvement. Compliance (10%) will measure the degree to which a school district and its individual schools meet the current State compliance requirements (ROE/ISC compliance probe). Evidence-based best practices (30%) will measure the degree to which school districts and their individual schools are adhering to a set of evidence-based quality standards and best practice for effective schools. These measures will be developed by ISBE and a stakeholder group established by the legislation. Contextual improvement (30%) will provide school districts and their individual schools the opportunity to demonstrate improved outcomes through local data (i.e. school climate, unique characteristics, and barriers that impact the educational environment and hinder the development and implementation of action plans). HB 2807	PA 99-130	Mitchell/Connelly	Amends the School Code to include as an approved professional development provider any Illinois museum that, as of the effective date of the amendment, has provided professional development and is approved by ISBE. Effective immediately.
HB 3093	PA 99-404	Durkin/Radogno	Amends the School Code to allow any high school district whose territory is in 2 counties and that is eligible for Section 8002 Federal Impact Aid to make a one-time declaration as to interest income not previously declared from 1998 through 2011 in the debt service fund, declaring said monies as interest earnings on or before June 30, 2016. Effective immediately.
HB 3123	PA 99-276	Pritchard/Althoff	Amends the School Code to revise the list of services that school counselors are permitted to provide in public schools. The bill specifically addresses how school counselors may support and/or serve students with disabilities. The bill specifies that school counselors may implement a student's IEP services, including academic, personal, social, college or career services. Effective immediately.
HB 3197	PA 99-432	Chapa LaVia/Collins	Creates the Attendance Commission within the State Board of Education to study the issue of chronic absenteeism in IL and make recommendations for strategies to prevent chronic absenteeism. The Commission is abolished on December 16, 2020. Effective immediately.
HB 3428	PA 99-358	Sente/McGuire	Amends the College and Career Success for All Students Act to provide that a student who takes a College Board Advanced Placement examination and receives a score of 3 or

Effective immediately.
