

## Illinois School Referenda Results—2007 Consolidated Election

There were 79 referenda introduced by 71 Illinois school districts in the April 17, 2007, consolidated election. These school referenda are sorted into three general types: tax, bond, and miscellaneous; and each is further categorized into several more detailed categories, such as building/construction, offices/boards/commissions, school/education, consolidation, etc. At times a referendum may be related to multiple categories. In these situations, the referendum is placed in only one category that best fits the referendum.

Among the 79 referenda, 28 are tax referenda, and they are all in one category: school/education, 40 bond referenda are sorted further into 4 categories, 30 into build/construct, 8 in school/education, and tax and miscellaneous categories each have 1 referendum. The 11 miscellaneous types of referenda are sorted into six categories ranging from boundary change to offices/boards/commissions. A summary of results, obtained on April 18, 2007, from participating school districts and county election departments, is listed in the following table.

Overall, 54 percent of the 79 referenda passed. The bond referenda fared better than others, with a 63 percent passing rate. However, voters did not approve 57 percent of the tax referenda in this election.
