Illinois School Referenda Results—2008 General Election

There were 24 referenda introduced by 27 Illinois school districts in the November 4, 2008, general election. These school referenda are sorted into three types: tax, bond, and miscellaneous, and each type is further sorted into one of the following categories: build/construct, office term/size, offices/boards/commissions/ school/education, and boundary changes.

Among the 24 referenda, four are tax referenda in the school/education category. Nine of the ten bond referenda are in the build/construct category and one is in the school/education category. The ten miscellaneous referenda fall into four categories: boundary changes, school/education, office term/size, and offices/boards/commissions. A summary of results, obtained on November 5, 2008, from participating school districts and county election boards, is listed in the following table.

Overall, half of the 24 referenda passed and half did not. Voters did not approve three of the four tax referenda in this election. One unique miscellaneous referendum passed as the first of its kind, authorizing two separate unit districts to jointly operate a cooperative high school.
