Chart 1. Number of Students Enrolled in RSSP by Student Eligibility: FY98-FY10

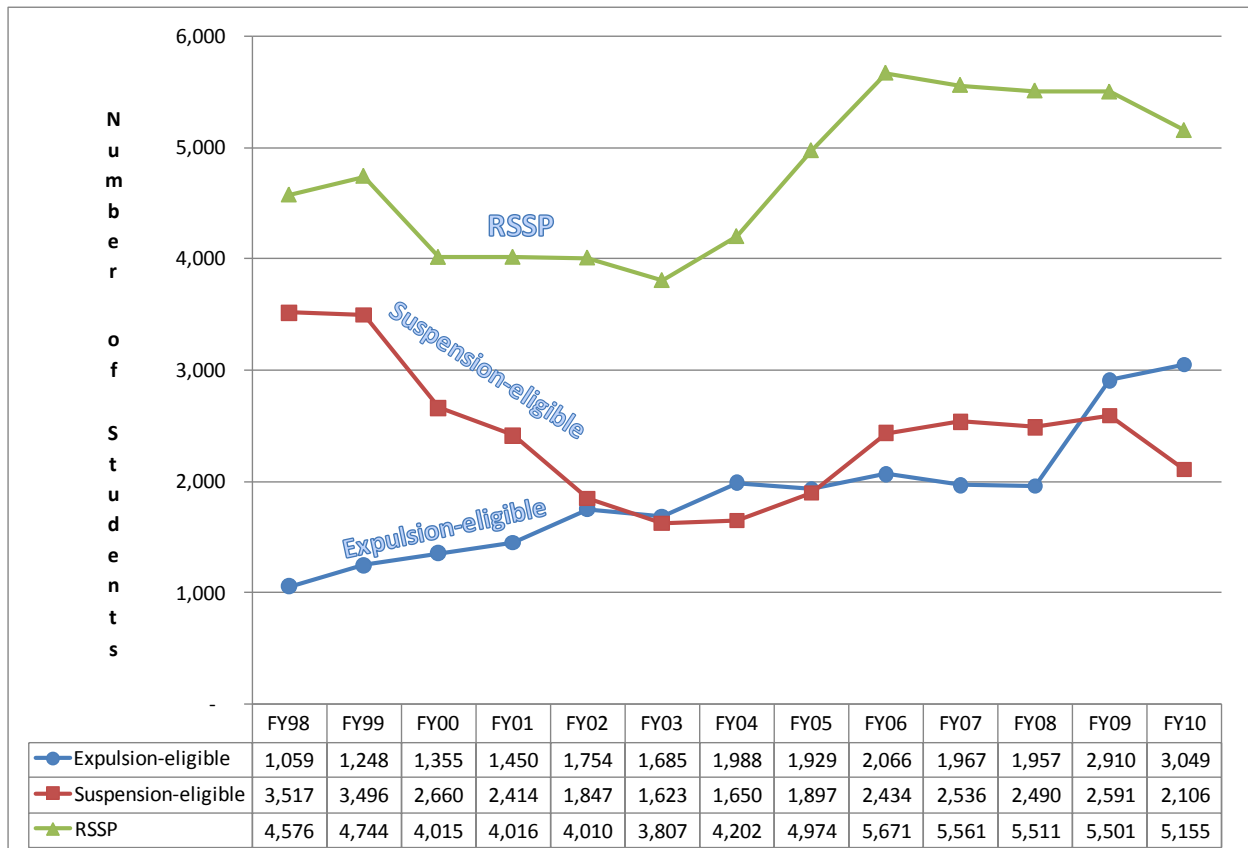

Chart 2. Percentage of RSSP Students Who Met or Exceeded State Standards in Reading and/or Mathematics, by Grade Level: FY10

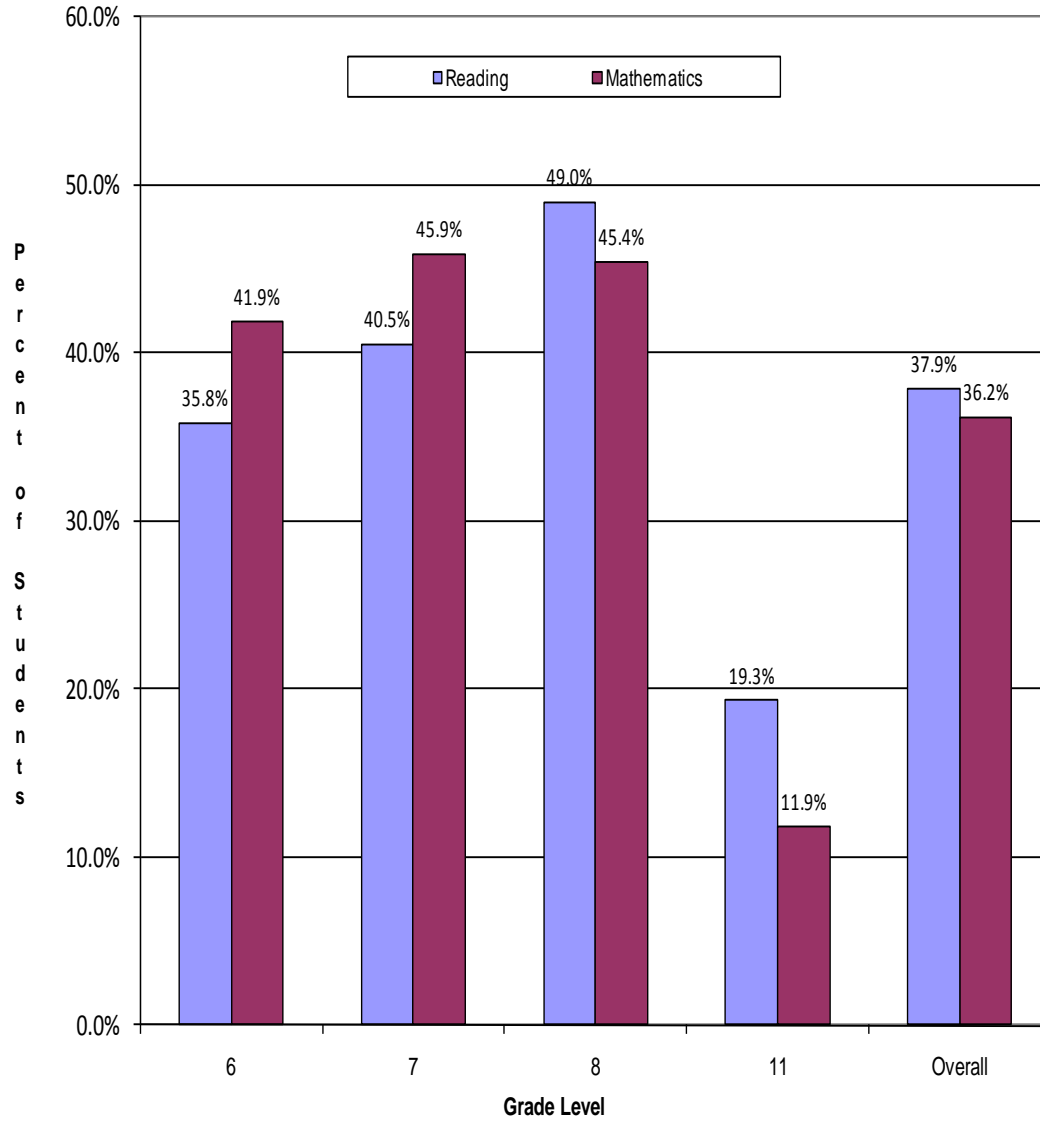


Chart 3. Percentage of RSP Students Who Met or Exceeded State Standards in Reading and/or Mathematics, by Eligibility Status: FY10

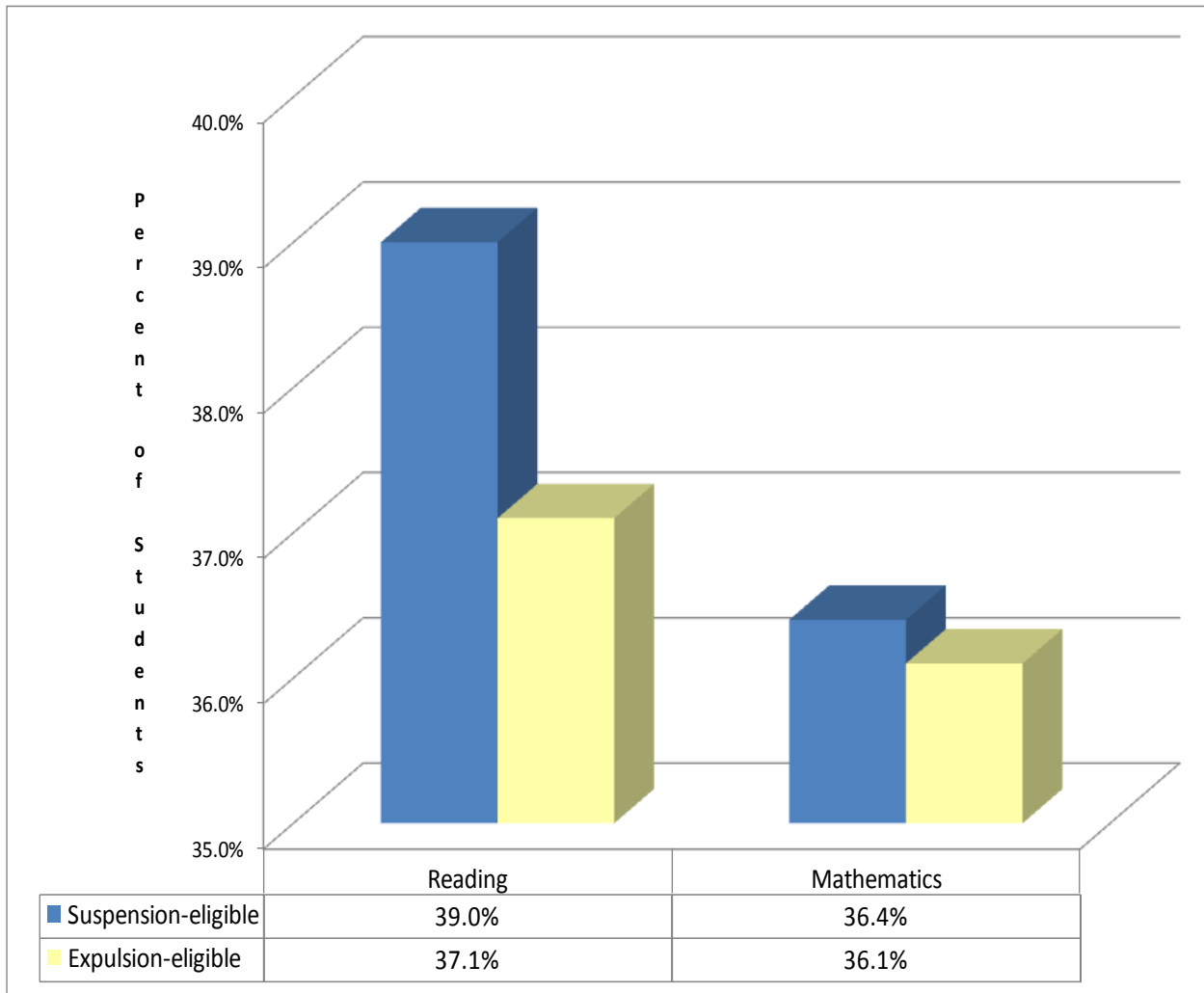


Chart 4. Percentage of RSSP Students Who Met or Exceeded State Standards in Reading and/or Mathematics, by Primary Referral: FY10

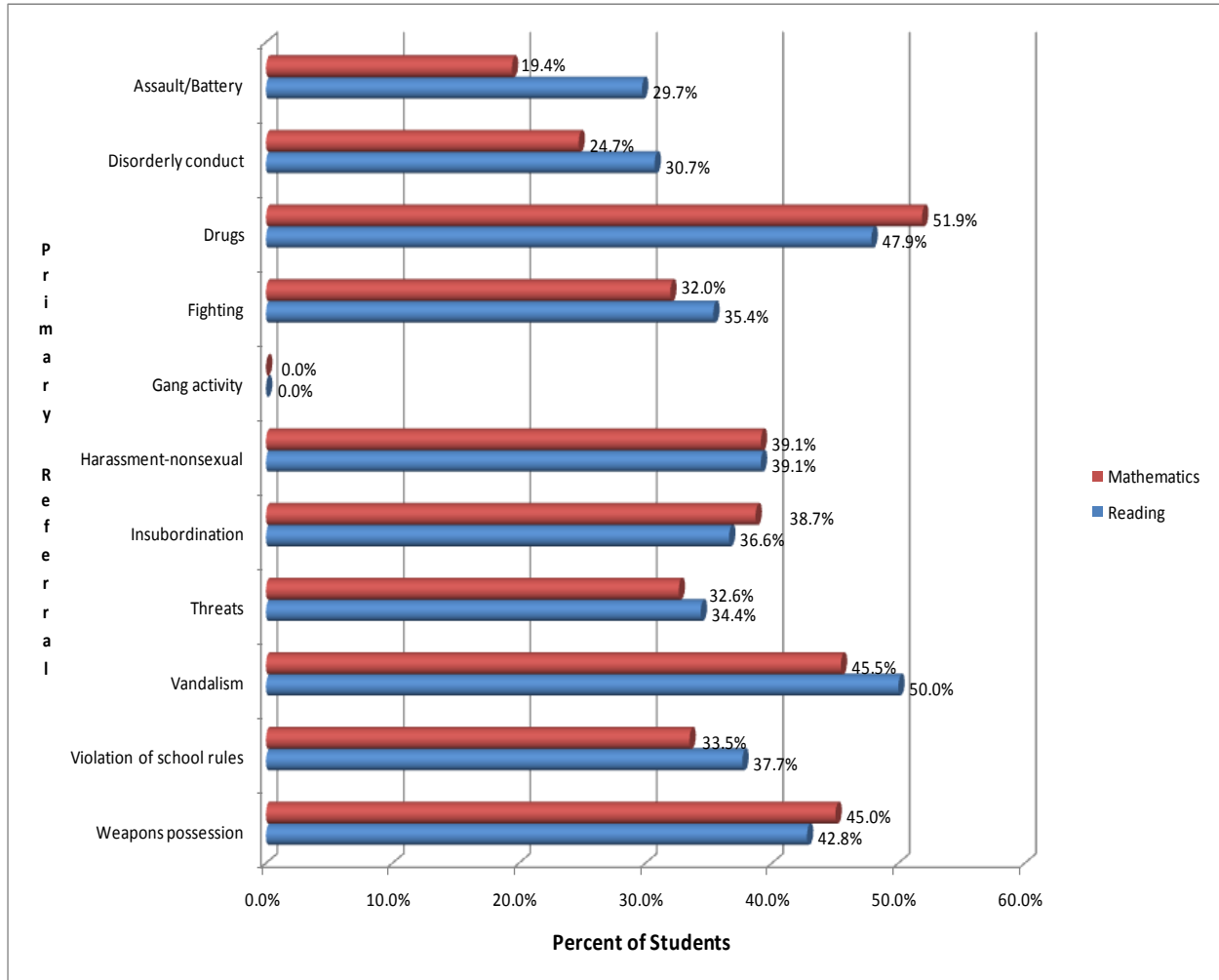


Chart 5. Percentage of RSSP Students Who Met or Exceeded State Standards in Reading and/or Mathematics, by RSSP Student Outcome: FY10

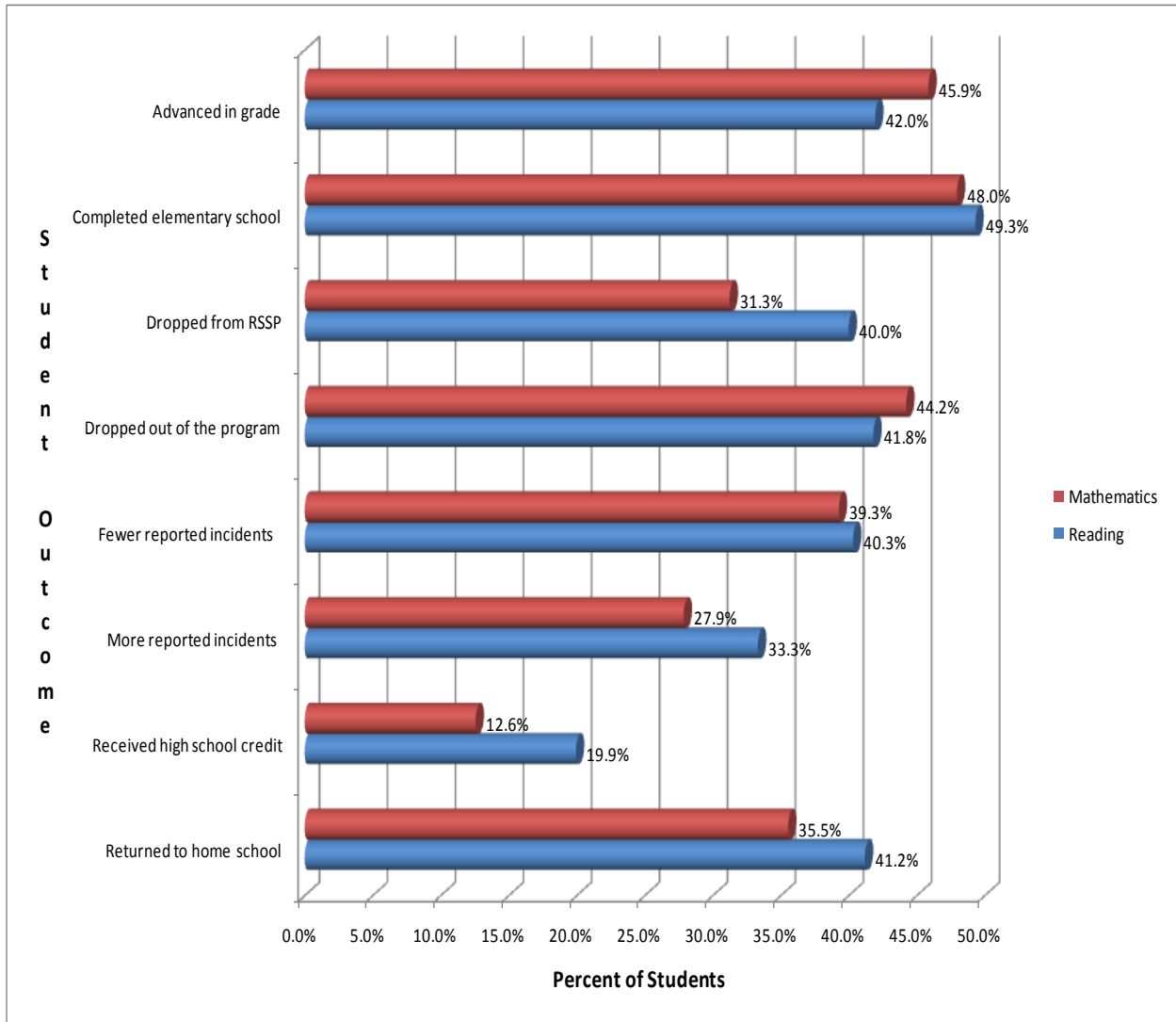
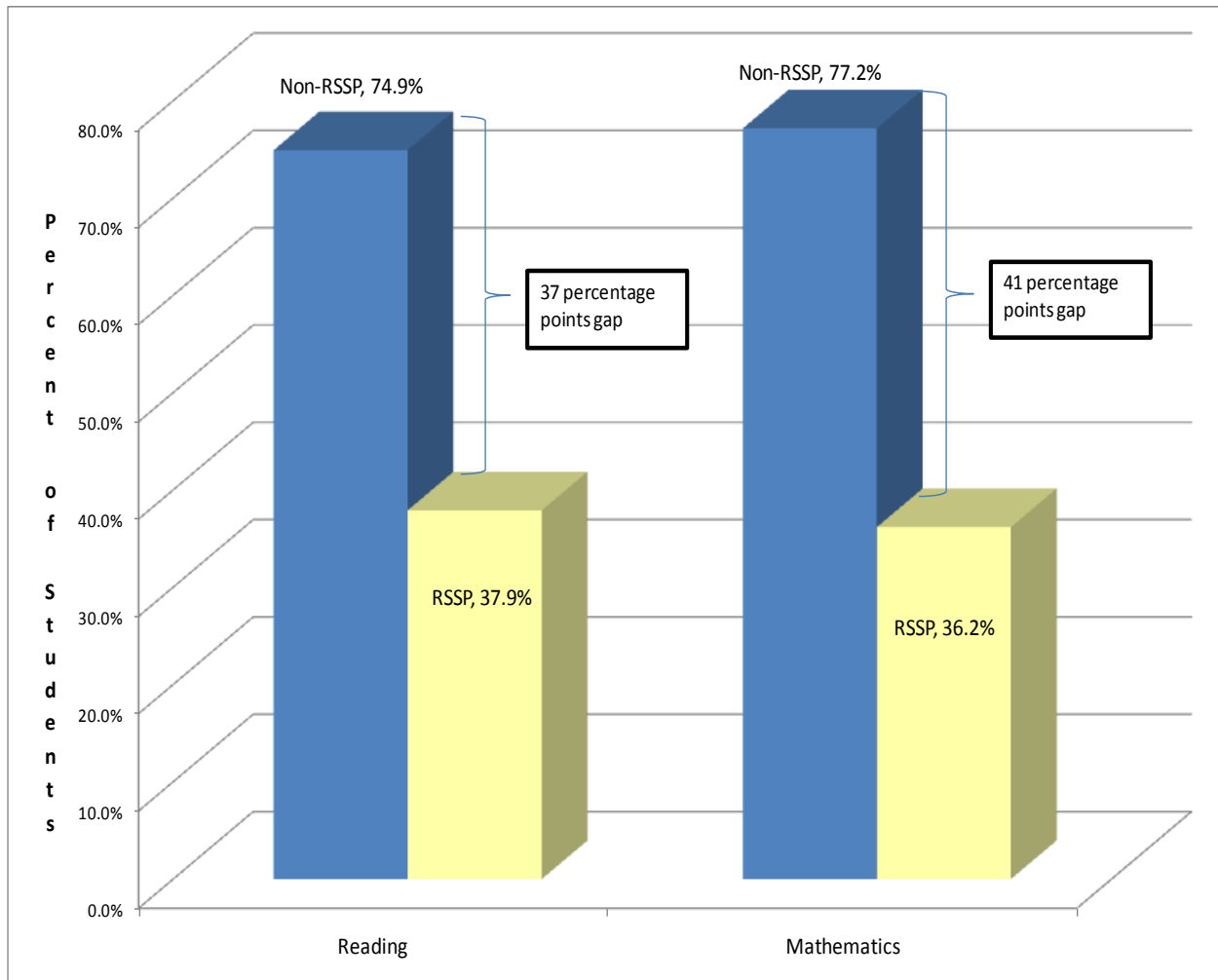
