#### Foreword

The Regional Safe Schools Program (RSSP) provides an alternative education option for students who are disruptive to the learning environment. The program offers several academic and age appropriate services such as work-based learning, behavior modification training, life skills training, counseling, mentoring, and community service in order to meet the individual needs of students. #### Background

The Regional Safe School Program (RSSP) serves expulsion-eligible students, suspension-eligible students, and those who have been expelled or have multiple suspensions in grades 6-12. The statewide program began serving Illinois students in FY97 as established by 105 ILCS 5/13A of the Illinois School Code providing a system of alternative education programs for disruptive students.

Because of the actions of a small number of disruptive students, local school districts face increasing problems in maintaining a safe environment for all students. Expelling or suspending disruptive students puts them on the street, which may increase safety and advance the learning environment inside the school premises, but does not serve the educational needs of the expelled or suspended students or the community's need for public safety.

The purpose of RSSP is twofold: 1) to increase safety and promote the learning environment in schools and 2) to meet the particular educational needs of disruptive students more appropriately and individually in alternative educational environments.

In its first partial (8-month) year (FY97), the RSSP went from planning stages to the development of program sites across the state of Illinois and served 1,325 students. In FY14, over 3,000 students were served by RSSP. Currently, there are approximately 70 RSSP program sites in Illinois in urban, suburban, and rural areas of the state.

The RSSP has 39 grants representing 38 Regional Offices of Education (ROEs) and the Chicago Public Schools. Grantees may run the RSSP programs or contract with local school districts or with third parties to run the programs. Individual programs may serve students in grades 6-12 or any combination of grades 6-12 based upon local needs and decision-making by the ROEs and local school districts.

The RSSP has a set of guidelines, based upon best practices for alternative programs. Each student has an Alternative Education Plan (AEP) and positive outcomes may include: reduction in disruptive behavior, regular attendance, coursework completion, advancement in grade level, return to home school, grammar or high school graduation, and completing a program leading to taking and passing the GED where appropriate.

#### Methodology

All student data in this report are taken from the ISBE Student Information System (SIS). RSSP student information is reported by schools and collected annually on a page in SIS that is specific to the program. In order to include student outcomes, the data used in this report are end of year data for SY14.

All students in grades 6-12 enrolled in RSSP are included in this data summary. It is important to note that the student enrollments in this data summary include multiple enrollments for SY14. For example, if "Student A" was enrolled in RSSP at a school district for a few days/weeks and then moved to a different district and was re-enrolled, this student would be counted twice. Since "Student A" was enrolled and utilized RSSP services at both districts at some point in time during SY14, both enrollments will be counted.

The state budget allocation data used in this report are taken from the Illinois State Board of Education's budget information section. These numbers represent the total dollar amounts that were allocated for RSSP in the state budget for the corresponding fiscal years shown.

Appendix A of this data summary breaks down RSSP enrollment by Regional Office of Education (ROE). The data used for this report were pulled from SIS when ROE consolidation had already taken place. Because the ROE's had not yet been consolidated in 2014, the current data were merged in order to accurately represent the pre-consolidation enrollment totals by ROE for SY14.

Every chart and table in this report includes notes as well as key data findings. In this data summary, RSSP's new eligibility categories are being fully reported for the first time. Starting in SY13, an amendment to the Illinois School Code required two additional eligibility categories to be reported. These new categories were collected in the ISBE Student Information System (SIS) starting in SY14. Definitions of these new categories can be found in Appendix B of this data summary.

## I. Annual RSSP Student Enrollments and State Allocations




Chart 1. Number of Students Enrolled in RSSP by Student Eligibility Status: SY09 to SY14



Findings:

From SY09 to SY14, there has been a decrease (-28.8%) in total RSSP enrollment. ٠

In SY14, Suspension-eligible student enrollment exceeded expulsion-eligible student enrollment for the first time since SY09.

- FY11 funding decreased significantly (-44.0%), while enrollment dropped by 17.4%.
- From FY09 to FY14 total enrollment decreased by 1,586 while total funding decreased by \$12,235,500.

- Since FY11 when a major allocation decrease occurred for RSSP (-44.0%), the program has continued to see a decrease in funding.
- Since FY09, enrollment has decreased by 28.8%, while state allocations for the program have decreased by 66.0%.
- From FY09 to FY14, estimated cost per student has decreased from \$3,369 per student to \$1,609 per student.

- In SY14, the highest percentage of enrollments transferred to RSSP by eligibility status was suspension-eligible (40.6%).
- The three highest percentages of RSSP enrollments by grade level were in Grade 9 (20.4%), Grade 10 (19.6%) and Grade 11 (19.4%).

In SY14, the three highest percentages of primary reasons for transfer to RSSP were due to: violation of • school rules (17.6%), involvement in fighting (17.3%) or because of the possession/sale/use of drugs (16.4%).

• In SY14, the highest RSSP enrollments were in Grade 9 (797 students), 36.4% of these ninth graders were transferred due to fighting in school (21.3%) or drugs (15.1%).

- The services that were most frequently used by all students enrolled were behavior modification (19.9%) and individual or group counseling (19.0%).


- RSSP's highest total outcome for SY14 was promotion to the next grade level (48.7%).
- Of the total number of outcomes for promotion to the next grade level (1,908), 43.7% were either expulsion-eligible or expelled, and 56.3% were either suspension-eligible or suspended.

- In SY14, 50.4% of outcomes for grades 9-11 were promotion to the next grade level.
- In SY14, 60.8% of outcomes for grade 12 indicated graduation.

Findings:

- This graph shows positive outcomes achieved by students enrolled in RSSP programs for SY14. Students enrolled in RSSP have individualized Alternative Education Plans (AEP) designed to promote safety and produce positive outcomes.
- In SY14, 48.7% of total outcomes indicated promotion to the next grade level.
- Transferring to public school districts within Illinois or within the same district can be seen as positive outcomes because students stayed in school and did not drop out.

#### **APPENDIX B- DESCRIPTIONS**

#### **Reason for Referral**

Alcohol- liquor law violations, possession, use, sale

Disorderly conduct- disruptive behavior

**Drugs**- excluding alcohol and tobacco (illegal drug possession, sale, use/under the influence)

Fighting- mutual altercation, battery, and/or physical altercation

Harassment- nonsexual (physical, verbal, or psychological)

Insubordination- disobedience to school staff or school personnel

**Robbery**- taking of things by force or theft

Threats- including school threats

Vandalism- damage to school or personal property

Violation of school rules- disobeying school policy

Weapons possession- firearms and other weapons

#### **Eligibility Status**

**Expulsion-Eligible -** A student who was expulsion-eligible and administratively transferred to RSSP in lieu of expulsion

**Suspension-Eligible** - A student who was suspension-eligible and administratively transferred to RSSP in lieu of suspension

**PA 97-0495-Expelled & Administratively Transferred -** A student who was expelled and administratively transferred to RSSP, in accordance with PA 97-0495 and Sections 10-22.6 and 34-19 of the School Code

**PA 97-0495-Suspended & Administratively Transferred** - A student who was suspended in excess of twenty(20) days and administratively transferred to RSSP, in accordance with PA 97-0495 and Sections 10-22.6 and 34-19 of the School Code

#### **Services Received**

**GED Instruction-** Enrolled in an instructional program leading to a GED certificate

**Tutoring-** Additional instructional services, usually provided on a one-to-one basis, to supplement regular instruction

**GED Test Successfully Completed-** Student successfully completed a GED test

**Curriculum Related Employment-** Student is employed or working in a position that is related to the curriculum

**Alternate Education Plan (AEP)** - Each student must have an AEP prepared at the earliest time following the transfer to RSSP. Requirements of the plan may be found in Illinois School Code 105 ILCS 5/13A-4

**Behavior Modification Training-** Any behavior management/conflict resolution training systems that help students improve their behavior, manage stress, control anger, and make better choices

**Community Service Participation-** This includes RSSP-sponsored or court-mandated participation in individual or group community service projects. These projects may be service learning projects or other volunteerism projects in which student learning is enhanced, the needs of the community are addressed, and the student provides service to the community

**Individual/Group Counseling-** RSSP programs may provide individual and/or group counseling that may relate to social, emotional, or health problems. Please note that clicking on this rubric indicates that the student received individual counseling, or group counseling, or both

**Life Skills Training-** This training may include decision-making (critical thinking, problem solving, and communication), social skills, cultural awareness, financial management, etc.

**Mentoring-** Coaching and/or guiding students with their career/educational goals. A mentor can be a peer, an older student, staff members, or a community member who may be employed in the career field in which the student is interested

**Parenting Classes for Parents (of RSSP students)** - The RSSP may provide parenting classes for parents of RSSP students as part of parental involvement in the RSSP program or as needed in individual circumstances on a case-by-case basis. Such classes may be provided directly by the RSSP or by referral to another agency

**Referral to Social Services -** The RSSP program may refer the student for services provided by government agencies, public or private social service agencies, or community-based organizations

**School to Work-** Career development training, skills training, and/or activities offered by the school to prepare students for jobs or employment
