Engaging Families to Make Pathways for Student Achievement In Evanston School District 65, families are being engaged in multiple ways. Core engagement activities include:

- Monthly family nights where parents come together to learn about afterschool programming. They also engage in peer exchange in learning about supporting youth development and academic success.
- Special events for parents to help them prepare for important moments from parent teacher conferences to the transition between fifth and sixth and eighth and ninth grades.
- In addition, family counseling by the district's trained therapists is available for families (both youth and their parents) dealing with family challenges ranging from divorce to social and economic hardship.

On a broader level, the district is in the process of expanding its
engagement efforts as part of the move toward community schools at
some of the 21st CCLC sites where the district has been able to recruit
additional support.

The first step toward developing community schools at Nichols and Chute will be engaging and repositioning parents as leaders in the schools. The Evanston school district's approach to family engagement will build on best practices like those documented by Soo Hong in her new book "A Cord of Three Strands: A New Approach to Parent Engagement in Schools" (Harvard Education Press, 2011). This research shows that community organizing practices are most effective at authentically engaging parents as partners in the community school.

Plans for engaging families include:

- Involving parents in open conversations about their interests, motivations, goals and challenges (e.g., Café y Conversación)
- Developing activities that invite parents into schools in specific ways that build on their strengths (e.g., Parent Mentors)
- Promoting parental leadership in schools by creating new spaces for leadership (e.g., Community School Action Team)
- Transforming school culture so that teachers and administrators view families as co-owners and co-authors of the school and community experience (e.g., Community Immersion Institute for Teachers)

In doing family engagement work, the Evanston school district hopes to achieve improved academic performance in core subject areas, increased involvement of all parents (especially low-income parents) in school committees and events, improved youth social competence, enhanced family relationships, enhanced school culture and an increase in the number of low-income parents feeling valued and included in school life.

Division of Innovation and Improvement

The Division of Innovation and Improvement has conducted numerous activities over the past 18 months in the area of Parent Involvement and Family Engagement. Beginning in the fall of 2010, in partnership with the Academic Development Institute, the Illinois Parent Information Resource Center and Great Lakes West, a series of webinars was conducted. These webinars were open to district staff, school staff, parent facilitators and parents. Topics included Creating a Welcoming Environment, Parent Involvement Resources, School-Home Communication and Parent Involvement as a Collaborative Process.

In the spring of 2011, a series of regional Parent Involvement/Family Engagement Summits was presented at various locations throughout the state. These summits engaged school district personnel in understanding Title One, Section 1118 requirements for parental involvement and planning activities. The summits were held in Oak Lawn, Lisle, Springfield and Marion. Follow-up summits were conducted in the fall of 2011, and school teams including parents, were in attendance. These summits provided opportunities for district staff to work with each other in developing action plans for family engagement. Panels consisting of practitioners who have been successful in engaging families in meaningful ways presented valuable insight and information at each summit.

To continue the work begun at the summits, a series of webinars was produced in the winter and spring of the 2011-2012 school year. These sessions focused on relevant topics and were facilitated by the practitioners who served as panelists during the summits. Topics included: High School Parent Support Centers, VIPs (Very Important Parents), Parent Involvement in High Poverty Schools, Engaging Families in Early Childhood Settings, At-risk Families, Response to Intervention (RtI) and ELL and Improving High School Family Engagement through Social and Emotional Learning.

Each webinar provided specific program and practice models that align with the research and evidence base and have yielded significant family engagement outcomes for students, families, and school improvement efforts. Please review these webinars for those examples that can be developed within your schools and districts and let us know how they are working.

The Division of Innovation and Improvement will continue this most important work in the coming months.

Center for Language and Early Childhood Development

The seventh annual Bilingual Parent Summit was convened in Oak Brook on Saturday, May 12, 2012. More than 700 parents and family members from 89 school districts across Illinois attended the summit. As an example, there were parents from school communities that included: Aurora East SD 131, Cicero SD 99, CHSD 218 (Oak Lawn), Beardstown SD 15, Bloomington SD 87, Carbondale SD 95, Champaign SD 4, Kankakee SD 111, De Kalb SD 428, De Pue SD 103, East Moline 37, Mendota HSD 280, Rantoul SD 137, Rochelle SD 231, Rockford SD 205 and City of Chicago SD 299.

At the summit, families heard from speakers that included Dr. Margarita Ramos from the Centro de Investigación y Asesoría Educativa (CIAE) in Monterrey, Mexico. Dr. Ramos focused on the Common Core State Standards and the critical importance for parents of ELL students to be aware and cognizant of these standards. Reyna Hernández, Assistant Superintendent of the Center for Language and Early Child Development at ISBE, also delivered a keynote address outlining many of the parent engagement initiatives that ISBE is undertaking, including supporting the annual Summit for Bilingual Parents. Other special guests who spoke at the summit included Gery J. Chico, Chairman of the Illinois State Board of Education, and Rita Gonzalez, Du Page County Board Commissioner, State Representative Linda Chapa La Via (D-Aurora) also attended the summit.

Parents also attended more than 35 breakout sessions and learned from:

The Records Keeper is a resource that is useful in keeping important information about dates, people, meetings, reports and copies of Individualized Education Programs (IEPs). The Records Keeper contains guiding questions to help parents prepare for IEP and transition meetings and get ready for evaluations and reevaluations. The booklet can be used to collect and file paperwork and other materials. The Records Keeper cross-references the Rights Guide discussed above.

Indicator 8 Webinars

Each year, in accordance with Indicator 8 of the Illinois SPP for IDEA Part B, ISBE is required to conduct a survey with parents of children with disabilities in order to receive feedback regarding their perceptions of how schools facilitated their involvement as a means of improving services and results for children with disabilities. The 25-question survey is mailed to a representative sample of parents throughout the state. The survey results are used for program improvement and reporting in the IDEA Part B Annual Performance Report to the U.S. Department of Education's Office of Special Education Programs. The Special Education and Support Services Division and PEP will be co-hosting three webinars to provide training and support to parents and school personnel as they work together to improve outcomes for students with disabilities.

The free webinars will discuss transition from school to work (August 21), state conflict resolution processes (September 11) and least restrictive environment (October 2). All webinars will be live from noon to 1:00 p.m., then archived on the PEP website at http://www.pepartnership.org/.
