ACCESS Material Ordering

The last day to place initial ACCESS 2.0 material orders is this Friday, November 18th, 2016. The additional ordering window will be from December 28th, 2016 to February 17th, 2017. Orders are placed on the www.wida.us website.

Note: Districts and schools that plan to test entirely online should indicate this via the WIDA-AMS materials ordering process. In the second table on the "Order Materials" tab, labeled "Online Order for School . . .", enter the number of students that will test online by grade cluster. The writing-only test booklets for grades 1-3 will automatically be sent; they should not be ordered separately. For students in grades 4-12, keyboard response is the default. Handwritten response is optional, but the writing-only test booklets for grades 4-12 cannot be ordered until the additional ordering window. The additional ordering window opens December 28th, 2016.

WIDA Screener

The online version of the new WIDA Screener is now available at www.wida.us. Illinois is not adopting the WIDA Screener for 2016-17, but educators are welcome to explore its features. Permission to access the WIDA Screener must be assigned to a user's account. District Coordinators on www.wida.us can assign permission.

Illinois-Specific Preparation Checklists

Illinois-specific ACCESS checklists will appear on www.wida.us this week. They emphasize local flexibility regarding the way tasks are assigned to staff. The Illinois-specifics lists will have a mixture of "X" and "D" in the role columns to distinguish which tasks should be done personally by someone in that role, and which may be delegated.

ACCESS Writing Field Test

WIDA is seeking EL students to participate in a field test of the ACCESS 2.0 Writing Assessment. It's for students in grades 1-12 at all proficiency levels. For grades 1-3, it is handwritten. For grades 4-12, it is keyboarded. Sessions are a maximum of 30 minutes long. It may be administered either before or after the 2017 ACCESS administration.

Field Test Windows

- Grades 1-3 November 11th, 2016 to late January, 2017.
- Grades 4-12 November 28th, 2016 to late January, 2017.

Access to it now requires that the account holder be given the W-APT permission, which also allows access to the materials. Account users who are District Assessment Coordinators on this site may assign these permissions to other users within the district.

The last day to submit changes to the ACCESS Pre-ID Label file is November 18th, 2016.

DLM

Required Training

- Required training is now open for all users for the 2016-2017 school year.
- All training needs to be completed by January 27th, 2017.
- New users need to be added by January 9th, 2016 in order to complete the required training. It takes 48 hours for an account to be established in Moodle.
- If you are new to the district and have completed the training in another district, then please update your user account with your new email address.

User Roles

- The only roles available for DLM are the following:
 - District Superintendent
 - District Test Coordinator
 - Building Test Coordinator
 - Teacher
- If a user has a role other than those listed, please have your DLM coordinator update the role to match a listed role.

Rosters

- Students in grades 3-8 and 11 will need to be placed in a roster for ELA and Mathematics.
- Students in grades 5, 8, and 11 will need to be placed in a roster for Science.
- Rosters should be listed as the following:
 - Teacher's last name, subject
 - Smith ELA
 - Smith Math
 - Smith Science
- Districts do not need to identify the specific course when creating the rosters.
- Districts only need to identify ELA, Math, and Science. If any other subject is selected, it will not deliver a testlet.



Data Lockdown

- Data lockdown begins February 6th, 2017.
- All rosters, required training, and users must be added prior to this date.
- All grade level corrections must also be completed prior to this date. If you are correcting a grade level, please make sure the grade is also changed in SIS.

District Score Reports

- District score reports will be sent out via mail to superintendents.
- If your district superintendent is not identified in Educator Portal, please have your DLM coordinator add or update the role of district superintendent.

Individual Score Reports

- The Individual Student Reports (ISRs) are available for the 2015-2016 in the Educator Portal as individual reports or bundled reports.
- District Superintendent, District Test Coordinator, Building Test Coordinator, and Building Principal have access to these reports.
