Report From the Search Committee

She explained that Proact Search, Inc. assisted in locating candidates meeting the criteria and helped guide the process.

She said that Board members conducted interviews with several finalists who best met the criteria for the position. She stated that after several interviews and numerous discussions, the Board had made a final decision.

Ms. Branch moved that the State Board of Education employ Dr. Robert Schiller to be the State Superintendent of Illinois starting August 2002 for three years, and authorize Chairman Gidwitz to sign the contract on behalf of the State Board of Education (see Addendum II).
