Illinois Timeline – Legislated by 105 ILCS 5/21B-30 (f) (from SB 1799)

Phase in by July 2013

Cut Scores have not been set.

Currently of design of 5 point scoring:

- 5 Exceptional
- 4 Beyond basic Proficiency
- 3 Proficient (new teacher)
- 2 Not quite there yet
- 1 Doing Harm

It is a summative assessment of teaching practice with:

Slide 12 - <u>Artifacts of Practice</u> - Planning, Instruction and Assessment with Daily Reflection Notes, Analysis of Teaching Effectiveness Commentary and Evidence of Academic Language. Development to be scored by Pearson.

Cost: \$300 eventually APT will not be necessary APT will be folded into the content test to be done during student teaching.

In IL over 60 institutions prepare teachers with varying standards. There are standards of operation but ISBE cannot oversee 900 teacher prep program for quality without checks and balances. This is actually a takeoff of NBPST wherein in the NBPTS process can be transferred.

This is a money maker for Pearson.

Scoring is very expensive this is actually a steal.

This is a one time score.

Questioning of the interrelated reliability.

Pearson won the bid, yes they will make some money but the scorers must follow rubrics for reliability and validity.

Data will be collected to compare institutions relevant to TPAC scores of the teacher prep students.

Strength of the Stanford Program in CA are the highly trained scorers. Calibration has been going on for years e.g. California.

ISBE hopes for a consistent Measure across the State with this design for factual data that can be measured and scored at the same level no matter which institution one may have attended. As K-12 educators, we want the best prepared teachers for the profession.

What happens when someone cannot pass the test when we are assessing them at the very end? Can the university be held accountable if they did not prepare the teacher to be able to pass the test?

Discussion: Should pay more attention during field work. This is one more way to weed out those who should not be in front of children.

Universities have been expressing concern regarding their teacher prep students being able to pass. It is not the State's responsibility.

The Licensure Board has been critiquing their process for entering students to evaluate the institutions and their programs and if their programs effective. There have been many questions during the last year regarding the programs especially institutions who want the principal prep programs. ISBE is carefully watching due to SB 1799. Many institutions are not prepared to answer the questions when the data does not support their decisions.

It is the institutions responsibility to back map.

Type I, Type II (key words: given by all teachers in a given grade or subject area) or Type III (based on a conversation between the evaluator and the teacher that this assessment will measure student growth that is aligned with the course curriculum and due to the teachers teaching skills) are defined on this slide with examples of each.

<u>Common Core Standards</u> – For ISAT, we are adding items written to the Common Core standards to the operational forms in 2013. Approximately 20% of the items appearing on the operational forms are written to the Common core Standards. Approximately 40% of the items in 2014 will be written to the Common Core standards. However, the format of the test is not changing. We will have the same number of items as before.

<u>Budget</u> – (<u>Sequestration request</u>) National Title I Association has a form on their website for stories concerning cuts to your Title I funding. Melina will send the link.

ISBE cannot recreate a new set aside. Suggestion to budget additional funds in "Homeless" in case there are necessary cuts.

Sequestration is the "law of the land" until Congress makes changes.

Currently the Sequestration adjustment amount is from 7.8% to 10.1% across the board. Only school lunches will not be touched.
