## Announcements

ISBE is advocating for the U.S. Department of Education (ED) to make waivers available for spring 2021 assessments as soon as possible. [Please see Dr. Ayala's February 5 message](#). Illinois will apply for a waiver as soon as one is made available. In the meantime, ISBE must proceed with the necessary preparations for administering assessments in case ED does not make a waiver available. Any state that would unilaterally decide to cancel assessments without an approved waiver in place would risk losing billions of dollars in federal aid for schools.

ED has released an [addendum](#) to the May 2020 COVID-19 fact sheet on English Learners (ELs). It answers several questions that have been frequently raised by state and Local Education Agencies (LEAs) in the past few weeks regarding the annual English language proficiency assessments and flexibilities that exist for statewide standardized entrance and exit procedures for the 2020- 21 school year.

## Applications for the FY 2022 EL - Title III Intent to Apply Are Now Available through IWAS

Applications for the EL - Title III Intent to Apply system are now available for school year 2021-22 (fiscal year 2022). The due date for the Intent to Apply application is **March 1, 2021**. ## Reminder: EL - eGMS - COVID - Student Information System Data Entry Update

EL data is due for Population in the electronic Grants Management System (eGMS) Ceiling Calculator by 4 p.m. April 27, 2021. This is the Student EL data only, not EL Screener data. It is very important that this data is correctly submitted for all students marked EL in the Student Information System (SIS) as it will be used to calculate EL-Evidence-Based Funding.

Most districts are educating students remotely during the COVID-19 pandemic. We understand the limitations of providing EL services when students are learning remotely. Please continue to enter the services the students would normally receive when you report EL students in SIS for SY 2021.

EL Placement - Status, Class Periods Provided Per Week, and EL Services Provided should be entered as if the student was in-person. To determine if your district is missing Student EL data, log into SIS and run the EL Detail Report. This report is in SIS; under Reports, choose the Bilingual Section and run the **EL Detail Report** (NOT Screener Report). You can also run the EL Detail Report from the SIS District Status Panel in the Data Completion Status box.

Take time and review your report; an “N” in column AA means that you are missing EL data for that student. This data needs to be submitted correctly to SIS by 4 p.m. April 27, 2021.

The EL data includes the following:

- Date First Enrolled in District/LEA
- New Arrival to U.S.
- EL Placement- Entry Status
- Date Student Enrolled or Re-entered to Receive EL Services
- Class Periods Provided per Week
- EL Services Provided

### ACCESS for ELLs Revised Dates to May 25

On December 17, 2020, ISBE revised the administration window for the ACCESS test, which measures the proficiency of English Learners in reading, writing, speaking, and listening. ## Guidance on Completion of English Learner Record of Provisionally Identified Students

Since October 15, 2020, new guidance from the Illinois State Board of Education Multilingual Department has instructed districts to complete EL demographic information, including the EL indicator and program information located in SIS, after a student was identified as an EL via provisional screening. This guidance revision was announced after receiving additional guidance from ED. This change is to ensure that a district's ELs are counted for state and federal funding (e.g., Evidence-Based Funding, Title III formulaic grants). For more information, [click here](#).
