Reminder: FY 2019 English Learners Evidence-Based Funding Expenditure Reporting

The fiscal year 2019 EL-EBF expenditure reporting shows where EBF funds attributable to ELs were ultimately spent within each district. At the recommendation of the Illinois Advisory Council on Bilingual Education, only districts that received \$5,000 or more in total FY 2019 EL funds will be required to submit an expenditure report through the period ending June 30, 2019. Additionally, carry forward was permissible in FY 2018. Any FY 2018 EL-EBF funds not expended in FY 2018 will appear in the FY 2019 expenditure report. Districts will not be permitted to carry forward funds from FY 2019 into FY 2020.

All districts should report <u>direct costs from July 1, 2018, through June 30, 2019</u>. All FY 2019 EL-EBF expenditure reports <u>were due to ISBE on July 20, 2019</u>. If you have not submitted your expenditure report, please submit it as <u>soon as possible!</u>

Updating Illinois Spanish Language Arts Standards:

Insights from the field

The Latino Policy Forum in partnership with Illinois Advisory Council on Bilingual Education conducted a survey to understand practitioner use of Common Core en Español Standards and interest in aligning the current Spanish Language Arts standards to Common Core. While Illinois has long had Spanish language arts standards, they are not aligned to Common Core nor the Illinois Learning Standards.



It is the hope that these survey findings illuminate the usefulness of Common Core en Español for Illinois practitioners. These findings are intended to inform future policy and advocacy efforts towards updating the state's Spanish Language Arts Standards and the development of an aligned assessment.

Updates/Reminders

Reminder: WIDA Secure Portal email logins

Educators who log in to the WIDA Secure Portal will be prompted to update their username to their work email address. This simple change makes it easier for users to remember login credentials and ensures accurate contact information.

Action Required: Transition from TSM to COS SD

The WIDA Consortium is transitioning from the Testing Site Manager (TSM) to DRC's new site management solution Central Office Service (COS) Service Device. Please encourage your districts to migrate to the COS Service Device in their configurations and to retire all of their TSMs before **August 15**. Beginning August 30, users with a TSM configuration will receive an error message when completing their readiness check.

The <u>Technology User Guide</u> and the <u>Tech Bulletin: TSM to COS Service Device</u>, available in the **General Information – Documents** section of WIDA AMS, walk you through the process of installing a COS Service Device and integrating it into an existing configuration using the COS Device Toolkit.
