

NEW! ACCESS Corrections and Data Review



Preliminary results for the ACCESS for ELLs Assessment will be posted for review in the Student Information System (SIS) on May 7, 2020. This is our opportunity to find and correct any errors before final reports are printed and shipped to schools. The review period is May 7 to May 27, 2020.

Demographic corrections for ACCESS can be made in SIS now through August 14th, 2020. This is done in SIS>Assessment Corrections>ACCESS.

Assessment data corrections do not change a student's ongoing demographic data in their SIS record.

In addition, ACCESS Percentile Growth Reports for 2018-2019 (published by WIDA) are available in the WIDA Secure Portal Dashboard. WIDA Secure Portal accounts with district-level permission can access the Dashboard and these reports.

NEW! WIDA AMS and 'Spring Cleaning'

Those district personnel that have experience with WIDA AMS, the screener and ACCESS management system, will want to view the recorded webinar regarding changes to the platform. Most of the changes are cosmetic, but the important item is that when the new look is rolled out on June 25, 2020 the existing data will be read-only. If there are existing students who have not had their assessments scored, they need to be completed

prior to June 25 or districts will be unable to complete the students screening. The webinar is in the WIDA Secure Portal in the Download Library.
