# Screening

## **NEW!** Provisional Screener of ELs Update

State and Federal law mandates the screening of all students who have a Home Language Survey that indicates screening is necessary. During Phase 4 of Restore Illinois, in-person instruction is allowed. Therefore, districts are expected to screen their students using the complete and official Illinois State Board of Education (ISBE) English proficiency screeners for Kindergarten (WIDA MODEL), grades 1-12 (WIDA Screener) and the prescribed screening procedures for PreK. ISBE recognizes that there are some districts across Illinois whose school boards have not only chosen to only provide 100% remote instruction during these initial days of school, but they have also banned students from entering school buildings temporarily. In this situation, in-person screening of potential ELs may be impossible but identification of ELs is still required. Therefore, the <u>provisional screener</u> may only be used by those districts where instruction is 100% remote and students are not allowed to enter school facilities. As soon as any in-person instruction is available then districts must officially screen all potential ELs using the mandated screeners.

Please note, provisional screeners may <u>NOT</u> be used in the case of a parent refusing to bring students into buildings to be screened. Districts should continue to make every effort to administer an official screener, think creatively about how to administer the screener (for example, meet outside the school building in the open air), and should document their efforts.

# **NEW!** EBF Spending Plan

As of August 1, 2020, the FY21 EBF Spending Plan is open in IWAS. On September 30, 2020, IWAS will close the submissions for this spending plan. As a reminder, every Organizational Unit ("Organizational Unit" is defined by all school districts, laboratory schools, Regional Offices of Education, and Intermediate Service Centers) in the state is required to complete an annual spending plan regardless of the amount of EBF dollars received. The EBF spending plan is designed to be completed as a collaborative exercise between the finance and program areas of a district to align available dollars with student needs and opportunities. Please note that for FY21 there will be no new tier funding provided. ### FY 2021 EL - Title III Language Instruction Educational Program Application

**Federal Title III grants** – The Multilingual Department is pleased to announce that the **FY21 Title III Language Instruction Educational Program** is now available for completion on IWAS. Please note that the title of the application changed from ELL-TBE/TPI and Title III to EL-Title III Language Instruction Educational

Program. Because this is a new application, program directors may have to sign up for authorization to enter and save information on the application.

To create a new application, districts need to select the EL-Title III Language Instruction Educational Program and check, "Yes" on the question, "Would you like to create new project for the current year?" Every district with an approved FY21 Intent to Apply should have their FY21 Title III LIEP applications ready for creation on IWAS.

This application does not include the Immigrant Education Program. A separate Title III Immigrant Education Program application will be released in November of 2020 when the districts eligible for the program are determined based on 2020-21 school year data. For information, <u>click here</u>.

# **NEW!** FY21 State Bilingual Program Directors Meeting

Robust collaboration between content and language teachers is essential for English learner success and achievement.
